Overview

The [U.S. Department of Justice](#) (DOJ), [Office of Justice Programs](#) (OJP), [Office of Juvenile Justice and Delinquency Prevention](#) (OJJDP) seeks applications for funding to develop, enhance, or expand programs for girls in the juvenile justice system and girls at risk of becoming involved in the juvenile justice system. This program furthers DOJ's mission to reduce recidivism and improve public safety by helping jurisdictions more effectively reinvest resources that empower girls in the juvenile justice system and at-risk girls with the skills needed to lower engagement in risky behaviors, further their own personal development, and/or facilitate successful reintegration of girls involved in the juvenile justice system.

This solicitation incorporates guidance provided in the [OJP Grant Application Resource Guide](#), which provides additional information for applicants to prepare and submit applications to OJP for funding. **If this solicitation expressly modifies any provision in the OJP Grant Application Resource Guide, the applicant is to follow the guidelines in this solicitation as to that provision.**

Submission Information

Registration: Before submitting an application, all applicants must register with the System for Award Management (SAM). You must renew and validate your registration every 12 months. Registration and renewal can take up to 10 business days to complete.

Submission: Applications must be submitted to DOJ electronically through a two-step process via Grants.gov and JustGrants.

Program Description

Overview

OJP is committed to advancing work that promotes civil rights and racial equity, increases access to justice, supports crime victims and individuals impacted by the justice system, strengthens community safety and protects the public from crime and evolving threats, and builds trust between law enforcement and the community.

[OJJDP's](#) guiding philosophy is to enhance the welfare of America's youth and broaden their opportunities for a better future. To bring these goals to fruition, OJJDP is leading efforts to transform the juvenile justice system into one that will [Treat Children as Children; Serve Children at Home, With Their Families, in their Communities](#); and [Open Up Opportunities for System-Involved Youth](#). OJJDP encourages all proposed applications that work with youth to highlight how the proposed program aligns with these priorities.

OJJDP envisions a juvenile justice system centered on the strengths, needs, and voices of youth and families. Young people and family members with lived experience are vital resources for understanding and reaching persons involved or at risk of involvement with youth-serving systems. OJJDP asks stakeholders to join us in sustainably integrating bold, transformative youth and family partnership strategies into our daily work. OJJDP believes in achieving positive outcomes for youth, families, and communities through meaningful engagement and active partnerships, ensuring they play a central role in collaboratively developing solutions.

Applicants must describe how their proposed project/program will integrate and sustain meaningful youth and family partnerships into their project plan and budget. Depending on the nature of an applicant's proposed project, youth and family partnership could consist of one or more of the following:

- Individual-level partnership in case planning and direct service delivery (before, during, and after contact with youth-serving systems).
- Agency-level partnership (e.g., in policy, practice, and program development, implementation, and evaluation; staffing; advisory bodies; budget development).
- System-level partnership (e.g., in strategic planning activities, system improvement initiatives, advocacy strategies, reform efforts).

With this solicitation, OJJDP will provide funding to communities to support girls age 17 and younger who are at risk of involvement and/or are involved in the juvenile justice system. Funding will support communities to develop, enhance, or expand early intervention programs and/or treatment services for girls involved in the juvenile justice system.

Statutory Authority

.34 U.S.C. § 11171-11172; Department of Justice Appropriations Act, 2023, Pub. L. No.

Specific Information

Girls involved in the juvenile justice system face a host of challenges and have a critical need for services. Many girls involved in the juvenile justice system experience trauma and other adverse childhood experiences such as physical and sexual abuse; poverty; and racial, ethnic, and gender biases, which can lead to their involvement in the juvenile justice system. They also experience family dysfunction, mental health and substance use problems, high-risk sexual behaviors, and school problems. Research shows that girls involved in the juvenile justice system need prevention and early intervention programs that are approached in a multisystemic, trauma-informed, and gender-specific manner.^[1]

Research also recommends improving training for judges, law enforcement, and juvenile justice staff to better serve girls. Improving system and programmatic responses for girls requires engaging a broad array of stakeholders. These include state juvenile justice specialists, state advisory groups, girls' alliances and coalitions, advocates, law enforcement officers, prosecutors, juvenile defenders, probation officers, victim service providers, researchers, and most importantly, girls and their families.

OJJDP believes that the needs of girls must be addressed in a developmentally appropriate manner. This means recognizing a girl's pathway into the juvenile justice system and limiting juvenile justice involvement to only those who pose a risk to public safety. Then, for those very few girls, it means reducing reliance on secure placement; implementing evidence-based programs; and creating healthy social environments with family, peers, community, social institutions, and society.

Goals, Objectives, and Deliverables

Goals

The goal of this program is to reduce risk factors and promote protective factors for girls who come in contact with the juvenile justice system, and place them on a path toward success, stability, and long-term contribution to society.

For the purposes of this solicitation, "at-risk girls" and "girls involved in the juvenile justice system" refer to girls age 17 and younger who are in need of guidance, treatment, or rehabilitation due to unhealthy behaviors (i.e., substance use, sexual exploitation, gang involvement, truancy, running away, delinquency) or have been arrested or referred for intake to a public agency (state, Tribal, city, or county) legally responsible for handling

criminal offenses.

Objectives

An applicant should address all the objectives that are relevant to their proposed program/project in the Goals, Objectives, Deliverables, and Timeline web-based form.

Funded sites under this initiative will work to accomplish the following objectives:

- Increase protective factors to prevent further delinquent behavior by girls involved in proposed programs funded under this solicitation.
- Improve juvenile justice system responses for girls in contact with the juvenile justice system.

Deliverables

An applicant should address all the deliverables in the program/project in the Goals, Objectives, Deliverables, and Timeline web-based form.

Applicants should discuss how they will implement the following deliverables in their application that will be delivered as a result of this program:

- Develop and implement direct service programs for girls involved in the juvenile justice system to reduce reoffending OR enhance or expand existing early intervention programs to meet the specific needs of girls at risk or involved in the juvenile justice system.
- Work collaboratively with the OJJDP training and technical assistance provider to implement a planning process, as needed, and identify and implement evidence-informed practices to reduce risk factors and promote protective factors for girls who come in contact with the juvenile justice system.
- Participate in an annual grantee meeting hosted by the OJJDP training and technical assistance provider.

Applications submitted by nongovernmental organizations must have a partnership via a draft or fully executed memorandum of understanding (MOU) or analogous document with public juvenile justice agencies at the local or state level. This will ensure close collaboration around referrals for those girls involved in the juvenile justice system and who are eligible for services provided by the proposed project. A draft or fully executed MOU or analogous document must be included as an attachment with the submitted application to be considered for funding. OJJDP expects these programs to be based upon best practices and may include a variety of services (i.e., in-home services, screening/assessment, educational, counseling, etc.).

The Goals, Objectives, and Deliverables are directly related to the performance measures that show the completed work's results, as discussed in the "Application and Submission Information" section.

OJP strongly encourages the use of data and evidence in policymaking and program

1. Priority Considerations Supporting Executive Order 13985, *Advancing Racial Equity and Support for Underserved Communities Through the Federal Government*

In support of this [Executive Order](#), OJP will provide priority consideration when making award decisions to the following:

A. Applications that propose project(s) that are designed to promote racial equity and the removal of barriers to access and opportunity for communities that have been historically underserved, marginalized, and adversely affected by inequality.

To receive this consideration, the applicant must describe how the proposed project(s) will address potential racial inequities and contribute to greater access to services and opportunities for communities that have been historically underserved, marginalized, and adversely affected by inequality, and identify how the project design and implementation will specifically incorporate the input or participation of those communities and populations disproportionately impacted by crime, violence, and the criminal justice system overall. Examples addressing this requirement include, but are not limited to, the following: budgeted project planning and/or implementation meetings with community stakeholders representing historically underserved and marginalized communities; outreach and/or public awareness campaigns specifically tailored to historically underserved and marginalized communities to encourage participation in the proposed project(s); budgeted incorporation of members representing historically underserved and marginalized communities in program evaluation, surveys, or other means of project feedback; and partnership with organizations that primarily serve communities that have been historically underserved, marginalized, and adversely affected by inequality.

B. Applicants that demonstrate that their capabilities and competencies for implementing their proposed project(s) are enhanced because they (or at least one proposed subrecipient that will receive **at least 40%** of the requested award funding, as demonstrated in the Budget Web-Based Form) identify as a *culturally specific organization*.

To receive this additional priority consideration, applicants must describe how being a culturally specific organization (or funding the culturally specific subrecipient organization (s)) will enhance their ability to implement the proposed project(s) and should also specify which populations are intended or expected to be served or to have their needs addressed under the proposed project(s).

Culturally specific organizations are defined for the purposes of this solicitation as private nonprofit or tribal organizations whose primary purpose as a whole is to provide culturally specific services to racial and ethnic groups, including, among others, Black people, Hispanic and Latino people, Native American and other Indigenous peoples of North America (including Alaska Native, Eskimo, and Aleut), Asian Americans, Native Hawaiians, and/or Pacific Islanders.

C. OJJDP will give priority consideration to applicants that demonstrate a commitment to ensuring fairness, equity, and access to justice for all children and families regardless of their race or ethnicity; religion; socioeconomic status; gender; age; mental health; cognitive, sensory, or physical disability; sexual orientation or gender identity or expression; geographic location; or other characteristics historically linked to discrimination or exclusion.

To receive this priority consideration, applicants must include in their application a plan that describes how the applicant will incorporate these values and priorities into their program design.

Note: Addressing these priority areas is one of many factors that OJP considers in making funding decisions. Receiving priority consideration for one or more priority areas does not guarantee an award.

- For nongovernmental agencies, an MOU (draft or fully executed) or analogous document with public juvenile justice agencies

If OJP determines that an application does not include these elements, it will neither proceed to peer review, nor receive further consideration.

Information to Complete the Application for Federal Assistance (SF-424) in Grants.gov

The SF-424 must be submitted in Grants.gov. It is a required standard form used as a cover sheet for submission of pre-applications, applications, and related information. See

Proposal Abstract

A Proposal Abstract (no more than 400 words) summarizing the proposed project — including its purpose, primary activities, expected outcomes, the service area, intended beneficiaries, and subrecipients (if known) — must be completed in the JustGrants web-based form. This abstract should be in paragraph form without bullets or tables, written in the third person, and exclude personally identifiable information. Abstracts will be made publicly available on the OJP and USASpending.gov websites if the project is awarded. See the [OJP Grant Application Resource Guide](#) for an example of a proposal abstract.

Proposal Narrative

The proposal narrative should be submitted as an attachment in JustGrants. The attached document should be double-spaced, using a standard 12-point font; have no less than 1-inch margins; and should not exceed 30 numbered pages. Tables, charts, and graphs included in the program narrative 30-page limit should be no smaller than 10-point font. If the proposal narrative fails to comply with these length restrictions, OJJDP may consider such noncompliance in peer review and in final award decision.

The Proposal Narrative must include the following sections:

a. Description of the Issue

Applicants should briefly describe the nature and scope of the problem that the program will address. The applicant should use data and research to provide evidence that the problem exists, demonstrate the size and scope of the problem, document the effects of the problem on the target population and the larger community, and describe what resources are needed to address the problem. Any data or research referenced in the narrative should include information about the source of the data and/or a citation.

Applicants should describe the target population and any previous or current attempts to address the problem. While OJJDP expects applicants to review the research literature for relevant studies, an applicant should also explore whether unpublished local sources of research or evaluation data are available.

b. Project Design and Implementation

Applicants should detail how the project will operate throughout the funding period and describe the strategies that they will use to achieve the goals and objectives identified in the previous section. Applicants should describe how they will complete the deliverables stated in the Goals, Objectives, and Deliverables section. OJJDP encourages applicants to select evidence-based practices for their programs. This section should also include details regarding any leveraged resources (cash or in-kind) from local sources to support the project and discuss plans for sustainability beyond the grant period.

Applicants should provide a detailed description of the proposed early intervention and/or treatment programs for the target population. If a program currently exists, describe how it will be enhanced. Applicants should also describe the target population, including eligibility requirements, the number proposed to be served, and justification and demonstration that this is an attainable number.

Applications submitted by nongovernmental organizations must have an established partnership via an MOU or analogous document with public juvenile justice agencies at the local or state level. This will ensure close collaboration around referrals for those girls involved in the juvenile justice system and who are eligible for services provided by the proposed project. - Any validation errors will immediately display on screen after submission.

- Once the application is submitted and validated, a confirmation message will appear at the top of the page. Users will also receive a notification in the "bell" alerts confirming submission.
