Bill. Thank you for your time on the phone today. I just wanted to recap what we discussed to make sure I didn't misunderstand anything and to keep us all on the same page.

We will of course comply with the state statute allowing the Jail Commission to exempt fire sprinklers; however, I would me remised if I did not say it is not without some concern.

Here is a recap our current situation.

Medical/Mental Health – ground up expansion.

- 1. We have received the Action Letter Chief Jaquess forwarded from the Jail Commission date August 2022 .
- 2. CCSO is waiting on Commissioner Court approval.
- 3. Architectural plans will show sprinklers in an effort to move forward with the project, however this is just informational for the FD since sprinkler plans are a separate submittal and approval.
- 4. Fire Sprinkler plans will show exempt areas and will be submitted with the Commission submittal details and a copy of the Action letter for documentation purposes and facilitate review.

Adult Detention Facility - ground up expansion, and Existing Jail

- 1. Submittal packet including engineer review being prepared for submission to the Jail Commission.
- 2. Current construction project is proceeding forward, while waiting on Commission response.
