Public Comments not related to an item on the Agenda.

Judge Hill recessed Commissioners Court at 1:32 p.m. and called to order the Health Care Foundation. The meeting was reconvened at 1:33 p.m.

Judith Dishong, Plano, came to provide a recap on the topics she has raised for the past few weeks as she feels there has been no progress. While attending Court last week, she developed a lack of trust due to how the subject of US380 was handled and how people were blindsided. Furthermore, while attending the US380 public meetings with TxDOT, she said people were told their input does not matter which was very

discouraging. Ms. Dishong also reiterated her concern regarding voter suppression. Although the final voting audit did not find any measurable evidence of fraud, Ms. Dishong is concerned the State Legislature is passing a law making unintentional voting mistakes a felony. She stated Texas is the hardest place in the country to vote, and she feels this law will make it worse. Ms. Dishong said her other concern is regarding the \$6.2 billion bonds issued during "snomageddon" which she said is very confusing for people. These bonds apparently are for taxpayers to pay back over the next 30 years because of the excess profits from the gas producers. She hopes the recent court ruling regarding these bonds will bring more clarity and provide necessary information. Ms. Dishong wants the government to be more straightforward and honest with their constituents.

Joshua Murray, Lavon, said he is concerned with consent agenda item 53685 regarding the usage of state forfeiture funds for the DA's (District Attorney) office to supplement salaries. He said it is ignorant to utilize unpredictable income for annual expenses. Mr. Murray said, in his opinion, it would be irresponsible of the County to use forfeiture funds to pay misdemeanor prosecutors additional money because the County cannot anticipate what those expenses would be. His primary reason for coming to Court today was to state his concerns regarding the CARES (Coronavirus Aid, Relief, and Economic Security) money the County allocated for food pantries since utilization has increased significantly over the last few years. Mr. Murray said the County received more than \$11 million specifically allocated for food pantries, but it appears some of the money did not go to actual food pantries. Mr. Murray said the Amazing Grace Food Pantry in Murphy did not receive any of those funds. However, the church formally known as the First Baptist Church of Wylie received more than \$200,000 of these funds even though their utilization of food pantries is non-existent. He said the church has completely renovated their exterior, redone the interior, and he has not seen them do any actual food drives. Mr. Murray asked why the funds would be given to organizations whose primary mission does not involve food pantries especially since some received over \$1 million from these funds. He asked the Court to audit these non-profit organizations to show where taxpayer money has been spent.

With no further comments, Judge Hill adjourned the meeting at 1:40 pm
