

Requesting Approval of Salary for Lateral Hire Thomas Peterson

Commissioners: I am seeking the blessing of the Collin County Commissioners Court to hire Thomas Peterson as a deputy sheriff with the salary of \$85,000/year (or \$6,590.00 above midpoint 556 of \$78,410), in light of his vast specialized training, qualifications and experience, and because of the desperate need of our organization to place such a qualified person as an investigator in our Child Exploitation Unit. Peterson is one of the most experienced experts in Texas regarding child exploitation and human trafficking investigations with over 25 years' of practical field service as a law enforcement officer. With the growing needs of the Child Exploitation Unit and the Child Advocacy Center, Peterson's experience is invaluable to the mission of the Collin County Sheriff's Office and the needs of our children in Collin County. Most notably, recent experiences have demonstrated how critical it is to have a CEU qualified deputy with the depth of expertise and experience necessary to make complex and difficult strategy and operational decisions required to successful bring these types of cases to trial. This work is so specialized, it's not practical to try and train a field deputy with no specialized experience to serve in this role, unless they are constantly supervised. The work is so technical and complex, mistakes are easily made at any juncture, this requiring constant supervision. This is not the case with Peterson. Thomas Peterson possesses the type of experience where he can be plug-and-played, with little supervision from day one, on even the most difficult child exploitation investigations.

Currently employed with the Office of the Texas Attorney General, Peterson has over six years of experience working to combat child crimes, human trafficking, and organized crime investigations across the State of Texas. Previous to employment with the Texas AG, Peterson worked for the Dallas Police Department for over 19 years. While with the Dallas PD, he worked with Homeland Security Investigations on a human trafficking task force. He possesses a Master's Degree from Arizona State University and holds a master peace officer's certificate. His annual compensation is currently \$84,015.00.

HR advises they are prohibited from authorizing any salary over \$78,410 (556 midpoint) without the permission of the Commissioners Court.

Explaining his background helps one to understand why we believe Thomas Peterson should be hired at a salary of \$85,000. Peterson has long cultivated relationships with federal, state

and local law enforcement agencies, as well as with non-government organizations (NGO's) in the area of human trafficking enforcement. His experience as a leader in the North Texas Trafficking Taskforce focused on "outside the box" approaches to investigations as he employed techniques in combating transnational organized crime in ways that resulted in convictions of criminals that traditional investigative techniques could not yield. These techniques included incorporating money laundering, conspiracy, racketeering and fraud investigations into human trafficking and related cyber-crimes. Peterson also has vast experience in the investigation of prostitution, gambling, burglary, white-collar crime, theft, organized crime, wire fraud, Title III (wiretap) and OCDETF investigations.
