**3. Executive Session Items:**

The Court did not recess into Executive Session.

**Public Comments not related to an item on the Agenda.**

Sherri Eubank, McKinney, asked the court to help save the largest remaining heavily forested area in central Collin County. The forest is over 220 years old and is one of the oldest in the state of Texas. She stated the forest will not survive with US380 bypass segment C. The construction will rip out all of the old trees and destroy the natural flowing water in the wet lands. In addition, many threatened species that live within the forest will be in danger. These are a few of the many reasons why Texas Parks and Wildlife opposes US380 bypass segment C. Ms. Eubank expressed her concern about the trash that will be thrown from vehicles and land in the marsh below the bypass. She said this area should be preserved and asked the Court if they would make a statement opposing US380 bypass segment C and supporting US380 bypass segment D.

Judith Dishong, Plano, said she does not think three minutes is enough time to discuss things thoroughly. She presented the court with an outline of things she has been concerned about over the past two years. Ms. Dishong said a dear friend of hers will be losing a horse property and honey farm due to US380 bypass segment C. She joined the meetings held by TxDOT (Texas Department of Transportation) and is very concerned. Her main concern is if there is a plan for the growth that will result from US380 bypass segment C. She is also concerned about the impact the bypass will make on the residents and their farms. She asked the court if McKinney has issued any bonds of improvement for the neglected east side.

Judge Hill asked Ms. Dishong to direct all questions regarding the City of McKinney to them since he is unable to speak on their behalf. He stated, at this time, TxDOT is accepting public comments regarding US380 which is their project, and he encouraged her to share her comments with TxDOT directly as well.


Amber Block, McKinney, spoke on behalf of Pam Weibley, McKinney. Ms. Weibley has lived in Collin County for 30 plus years and has raised three sons here. She and her husband are retired seniors living on a fixed income and cannot afford to move. They planned on staying here forever. She is not sure what will happen living so close to a highway and is concerned how it will affect others within her home. Ms. Weibley knew that one day the area would grow, but she did not think the road growth would go through the neighborhoods and nearby ranches. US380 bypass segment C will run through her property, divide up her community, and take away her neighbor's homes. Ms. Weibley does not want a bypass in her backyard. She agreed we need a bypass, but US380 bypass segment D is a better choice. She asked the Court if they would please oppose segment C and support segment D. Ms. Block asked the Court, if TxDOT said their opinion does not matter, why would her opinion matter.




Judge Hill said it is not that the Courts opinion does not matter. TxDOT is not looking for political entity support or opposition at this point. They are looking for any feedback from anyone. Specifically, they're looking for any items that would change their environmental analysis.

Joshua Murray, Lavon, stated he was disappointed agenda item AI-53644 was pulled. Mr. Murray said, when you look at the adopted salary for the District Attorney's office, it shows there is a salary surplus. The reason being every year Collin County has funded positions that go unfilled. Every corporation will have positions that go unfilled, but Collin County's percentage is much higher than it should be. He said, if there are 150 employees that are unfunded positions, and each one costs \$50,000, it would be equal to \$7.5 million. He also said Collin County does not have infrastructure to support the population it currently has. Mr. Murray mentioned the Juvenile Detention Center, Animal Shelter and the Courts. Due to these issues, the court will probably have to raise the taxes on people. He encouraged the Court to come up with a plan to fix it not just for now but for five years from now. (Time 1:56p.m)

With no further comments, Judge Hill adjourned Commissioners Court at 1:56p.m.




