Gentlemen:

We will officially start staffing for Trinity Falls on May 1, 2023

I write this email to determine if Trinity Falls MUD 1 and MUD 2 would prefer both (2) Deputies, that are assigned and any future Deputies that will be assigned in the future to Trinity Falls MUD 1 and MUD 2, to work an 84 hour schedule in lieu of the 80 hour schedule outlined in the ILA agreement.

This will allow for future 24 hour coverage, 7 days per week with 12 hour schedules (schedule worked by all Patrol Deputies and Deputies that work for the City of Lucas) . As of now, one day per week would be 8 hours for each Deputy instead of 12.

This will result in a higher amount billed for the 84 hours versus the 80 hours worked by each Deputy in a two week pay period.

I spoke with Mr. Thomsen today by phone and Mr. Thomsen agreed to the 84 hour schedule. I attempted to call Mr. Wilson but was unsuccessful in reaching Mr. Wilson.

I need a response from both MUD 1 and MUD 2 that you agree and I'll send a memorandum forward to change to 84 hours. If not, please let me know that and we will stay at 80 hours.
