Good morning,

I have been assigned your diversion application which have now been labeled 23-D0216. Over the next few days I will be completing my review of the application and submitting it to the TJJD committee for staffing. Please be advised that we require 5 business days in which to complete our process. . I will do my best to get you a response back before the March 29, 2023 court date.

Below is a list of requirements that the TJJD committee will focus on during our staffing. Please read them carefully, as they have changed.

- Does the application meet target population? The initial target population of youth are all youth who are eligible, and under consideration, for commitment to TJJD.
- Does the application meet any of the priority populations? These include:
- Younger offenders (those between the ages of 10-14);
- Youth with a serious mental illness;
- Youth with a developmental or intellectual disability;
- Youth with non-violent offenses; and
- Youth with low- to moderate-risk levels for re-offense
- Youth for whom have a clear concern they have been, will be or are being sex trafficked, as defined in Section 20A.02. Penal Code; or

- Youth who have 4 or more adverse childhood experiences (ACE'S)
- Have department interventions been appropriate? In order to qualify, the juvenile probation department must demonstrate a prior effort to provide appropriate intervention with priority given to the treatment needs of the youth. Intervention should be commensurate with county resources.
- As provided by the department and reviewed by the assigned administrator can the identified treatment needs be met at the recommended facility?
- If outside the region why?
- Is the recommended length of stay and cost per day appropriate?

Once the staffing is held and a decision is made, I will contact you immediately with the outcome. If for some reason the application is denied, it will be for one of the reasons above or a combination of those regional requirements. If you have any questions please don't hesitate to contact me.
