Judge Hill called to order the Special Session of the Collin County Commissioners Court at 11:03 a.m.

Judge Hill said our hearts are heavy due to the passing of R.D Foster earlier this morning. Mr. Foster was a Marine Corps veteran, author, musician, historian, artist and a part of the two-man team that started the Collin County Fallen Warrior Portrait Project and got it to the point where it is today.

COMMISSIONERS COURT BUSINESS:

Colin Kimball, graphic artist, came forward to present two portraits of Collin County Fallen Warriors to be put on permanent display.

James Oliver Trosclair, 21, McKinney, graduated from McKinney High School. He served as a radio operator in the United States Air Force as an Airman 1st Class, in the 371st Bomb Squadron, 307th Bombardment Wing. He was shot down September 13, 1952, while making a bomb run on the Suiho Hydroelectric Plant in North Korea. He was listed as "missing in action" and declared dead on February 28, 1954. His body was never recovered. He is listed on the National Korean War Veterans Memorial in Washington, D.C. and the Honolulu Memorial in Honolulu, Hawaii.

Pedro Renaldo Perez, 22, Plano, graduated from Plano High School. He was a Sergeant who served in the Army National Guard as a medic assigned to the 156th Engineer Battalion, 56th Infantry Brigade Combat Team, 36th Infantry Division. He was on active duty with the Texas National Guard serving on Joint Task Force Operation Lonestar when he died from injuries received in a traffic accident on July 15, 2022. He is buried in Ridgeview Memorial Park.
