Public comments related to an item on the Agenda.

Avis Novak, McKinney, said she opposes agenda item AI-54496. She asked the Court why the supporting

documents are not included on the agenda since it is hard for the public to see what is going on when those documents are not available. For the upcoming November election, the Commissioners Court is

statutorily required to select a voting method. Texas Election Code Chapter 123.001 states the

Commissioners Court has legally verified the voting system complies with all of the requirements in the Texas Election Code chapter 122.001 section A1-10. One of those requirements is the system complies

with the voting system standards adopted by the United States EAC (Election Assistance Commission).

The voting program manual requires the system be tested by highly accredited voting testing system

laboratories in order to be an EAC certified system. The EAC also publishes their voting system test

laboratories program manual. Section 3.6.1 of the manual requires the chairman of the EAC to sign the accreditation certificate. None of the accreditation certificates have been signed by the chairman since

2015 which invalidates both of the accreditations and the voting systems certifications. The EAC chairman

is appointed by the Executive branch and confirmed by the Senate which shows the importance of signing

the accreditation certificates. Ms. Novak recommended the Court verify the signatures on the

accreditation certificates for the laboratory responsible for testing the voting system prior to the next

2. Executive Session Items:

The Court did not recess into executive session.

Public Comments not related to an item on the Agenda.

Debra Boehm, Plano, said for over two years concerned citizens have been petitioning the Court to add election integrity to the agenda. Real data, facts, and proposed solutions have been given to each of the members of the Court. Election integrity and cyber security experts have come to Collin County to share their knowledge, offer their help, and some have offered personal one-on-one meetings. The Court has seen the multitude of vulnerabilities in Collin County's election systems. Judge Hill and Commissioner Hale were present when Clint Curtis, the original creator of election software, said "I wrote the prototype. I wrote the program. It can be hacked. In programming, the programmer runs the world. Hacks are everywhere, if the County tells you they have it under control, they are either fooled, clueless, or lying to you. Throw away the machines. It is impossible to secure a computer. The log that I give you is the ballot image I want you to see. The Secretary of State gets a copy of the source code but they do nothing with it. Every program has a back door. It must. A chip can also have a back door. Every chip set comes from China. Don't use computers." Another expert, whose presentation was also viewed by Judge Hill and Commissioner Hale, said this is a national emergency. We need to get rid of the machines immediately. Ms. Boehm agreed it would be more difficult to go back to hand counting hand-marked ballots, but it is worth it. (Time: 1:39 p.m.)

Chuck Reynolds, Celina, said elections are the bedrock of this nation. The biggest election responsibility is at the local level because it is closest to the people. He thanked the Court for their good work in executing the election process in the past. We now face a completely different environment. Technologically, there is a whole new reality. Freedom is not free, and freedom will not survive on autopilot. Mr. Reynolds said 62% of citizens believe election outcomes are being impacted. Attorney Kurt Olson said there was a recent independent state court ruling which was one of the most significant decisions in the past 100 years. It

came out of the western district of Louisiana in a case called Missouri vs. Biden. This case was on the subject of censorship. The ruling said what the government did in censoring Americans was the most significant violation of the Constitution in all of American history. Proprietary secret software, barcoding, foreign computers, back doors on computers, Trojan chips, out of date security software protocol, insufficient supplier testing of the election machines, non-secure supplier provided memory sticks are injected into our election machines. The evidence is coming out across the nation. Their concerns are justified. It is the opposite of complicity and transparency. It is not the matter of if but when. Freedoms are at stake, and help is needed for the 2024 elections. Counties must hand mark and hand count their ballots. (Time: 1:42 p.m.)
