RE: Health Services Agreement - Renewal Year 2024

Greetings Mr. Alley:

Per our conversations, please see below our renewal ask for the County's 2024 fiscal year. We are fortunate to partner with the Collin County. We have provided information and details of our ask and hope to hear from you soon.

Contract Renewal

Per Section 9.3 of our agreement, the base compensation and per diem rate will include a reasonable increase at the end of each 12-month period of the Agreement to ensure the delivery of the same quality and quantity of healthcare services.

Compensation Adjustment

Wellpath would typically request a CPI increase consistent with the 12-month percent change in the Consumer Price Index ("CPI") for Urban Consumers – Dallas-Fort Worth TX, for the Medical Care Services Component, for the month of May. Medical Care Services are not reported by the Bureau of Labor Statistics for the Dallas-Fort Worth area. Therefore, we will share and report on the Consumer Price Index ("CPI") for Urban Consumers – Dallas-Fort Worth TX, for the Medical Care Component, for the month of May which is 1.8% for 2023.

To maintain the quality and standard of medical services provided to the inmates and it is necessary for us to adjust the contract amount to reflect the current market rates. Therefore, we request to increase the contract amount by **4.7%**. We understand the budget constraints of the County and the contractual identified terms of increase. Given these items, we are willing to adjust our proposed CPI increase from 4.7% to 1.8% and intend to make a future request clarifying the CPI dates and language within the contract.

The 1.8% CPI adjustment would increase the per diem rate from \$1.49 to \$1.51 and shall increase the contract total for Juvenile Services by \$11,516.52 annually and Adult Services by \$202,036.58 annually for a total proposed increase of \$213,553.09 annually or \$17,796.09 monthly.
