Problem Statement:

An inability to secure beds for juveniles who have engaged in violent delinquent conduct has greatly compromised community protection for citizens across the state of Texas. In order to provide critically needed relief for local probation departments who do not operate a juvenile detention and/or post-adjudication program, the Texas legislative adopted Senate Bill 1727 which in part appropriates additional funding to the Texas Juvenile Justice Department (TJJD) specifically to increase the capacity of pre- and post-adjudication facilities operated at the county level of the juvenile justice system. There are currently 39 juvenile detention facilities registered and certified to detain youthful offenders currently in Texas. These facilities are funded and operated almost exclusively at the local level with TJJD providing operational support and oversight pursuant to the Texas Administrative Code. Recent data shows the need for additional capacity will continue to be critically important to move the juvenile justice system forward.

Goal Statement:

The Collin County Juvenile Probation Department currently funds and operates a 144 bed, secure detention facility. The department currently partners with several departments within the region and across the state to provide contract detention beds for serious, felony offenders who are alleged to have engaged in delinquent conduct to promote community protection for Texas citizens. This application seeks to bring additional, existing bed capacity, and additional staffing required to bring an existing pod for Collin County online to expand regional detention bed capacity with an emphases on violent felony offenders, and youth with a history of violent and aggressive behavior toward juvenile justice staff which have historically proven difficult to place or detain.

The department seeks to dedicate 4 detention beds for the north region designated for felony, high-risk, high-need juvenile offenders. This pod will have an increased staffing matrix in order to accept more violent and

mentally acute youth who are becoming more prevent and have proven to be difficult to serve historically.

Describe Capital Expense Resources:

New officers will need radios for performing juvenile supervision duties.

Describe Staff Resources:

The department will recruit, provide all required uniforms and resources for the scope of duties, and certify officers needed to open and operate an existing juvenile detention pod in the facility. In order to meet the critical need for appropriate staffing levels for this target population (high-risk, high-need, felony offenders; and those with a history of acute mental health), the department will incorporate a staffing matrix greater than state standards minimums to promote greater safety for referred youth and juvenile supervision officer retention. The Collin County Juvenile Probation Department currently operates pursuant to TAC: 343 standards for direct supervision at a ration of 1 officer to 12 youth. For Prison-Rate Elimination Act (PREA) requirements, the facility adhered to a 1:8 ratio for supervision. In order to accept this difficult to serve youth, Collin County will look to increase the staffing matrix for this new pod in order to promote safety and security, promote better outcomes for the kids, reduce local laiblities for incidents in dealing with volatile youth from other jurisdicitons, and mirror new best practices in mitigating risk.

Notes or Comments:

The department currently has physical capacity to bring additional regional beds online but lack staffing and funding resources to do so. The department will seek to implement an increased staffing ratio for one (1) additional pod which will allow the department to increase protective factors for more volatile youth who have refused by local departments historically due to increased risk and suicidal histories. Additional staffing will be needed to ensure compliance with minimum standards for youth who require suicide watch and increase protective factors in the pod. Having a multiple officer approach for these more volatile youth will also positively impact retention and allow the department to safely take kids the department has been unable to accept for detention in the past.

▼ Program Focus:

Program Title:

Regional Detention Beds

Project Summary:

The project will expand detention contracting capacity for felony offenders within the region. The department will prioritize an increased staffing matrix for youth who have historically been unable to be detained due to aggressive histories and higher supervision requirements. The juvenile detention facility operates with four (4) rotating shifts, each of which work 12 hour shifts. The department will seek to add two (2) additional certified officers to each shift which will allow the agency to open an additional pod and dedicate four (4) beds to the region for detaining serious, felony offenders.

▼ Program Approach:

Approach:

The John R. Roach Juvenile Detention Center is a 144 bed secure detention facility located and operated in Collin County Texas. Currently the facility is staffed to provide both pre-adjudication and post-adjudication detention services for a maximum of 120 juvenile offenders. With additional funding for staffing and operational needs, the department could make additional beds operational for departments within the region who do not have a facility.

Regional Approach:

If funded, Collin County will continue to contract with regional probation departments for detention services as established and these four (4) additional beds will be available to the region (pre-paid) without a contract cost with an emphasis on felony offenders with higher acuity.

Trauma Informed Care:

The John R. Roach is committed to fostering a Trauma Informed Care approach to service delivery. All departmental staff are trained in TBRI and the facility currently has TBRI practitioners within the administrative leadership team. Additionally, the department has multiple licensed LCSW clinicians on staff who make regular rounds to check on kids in pre-adjudication and provide support clinical services as needed.
