The City of Plano agrees to be the applicant/fiscal agent of the 2023 Byrne Justice Assistance Grant (JAG) Program.


The funds for this grant will be distributed as follows:



INTERLOCAL AGREEMENT BETWEEN THE CITY OF PLANO, CITY OF MCKINNEY, CITY OF FRISCO, AND THE COLLIN COUNTY SHERIFF'S OFFICE OF COLLIN COUNTY, TEXAS FOR THE DISBURSEMENT OF THE EDWARD BYRNE MEMORIAL JUSTICE ASSISTANCE GRANT (JAG) AWARD

This Agreement is made and entered into this ____ day of _____, 2023, by and between the City of Plano, acting by and through its governing body, the Plano City Council, hereinafter referred to as City of Plano; the City of McKinney, acting by and through its governing body, the McKinney City Council, hereinafter referred to as City of McKinney; the City of Frisco acting by and through its governing body, the Frisco City Council, hereinafter referred to as City of Frisco; and the Collin County Sheriff's Office, hereinafter referred to as CCSO, collectively (the "Parties" or each "Party").

WHEREAS, the Parties have agreed that the City of Plano would serve as Fiscal Agent for the Edward Byrne Memorial Justice Assistance Grant Formula Award, (hereafter the "JAG Award"); and

WHEREAS, this Agreement is made under the authority of Public Law 109-162 (Jan 5, 2006) Title XI—Department of Justice Reauthorization, Subtitle B—Improving the Department of Justice's Grant Programs, Chapter 1—Assisting Law Enforcement and Criminal Justice Agencies, Sec. 1111, Merger of Byrne Grant Program and Local Law Enforcement Block Grant Program; and

WHEREAS, the governing body of each Party, in performing governmental functions or in paying for the performance of governmental functions hereunder, shall make that performance or those payments from current revenues legally available to that party; and

WHEREAS, the governing body of each Party finds that the performance of this Agreement is in the best interests of the Parties, that the undertaking will benefit the public, and that the division of costs fairly compensates the performing party for the services or functions under this agreement; and

WHEREAS, the Parties believe it to be in their best interests to reallocate the JAG Award funds.

NOW THEREFORE, the Parties agree as follows:

1. City of Plano agrees to forward to CCSO a total of **\$19,073.00** of the JAG Award funds which will be used by CCSO to purchase red dot equipped weapons to enhance officer and public safety.
2. City of Plano agrees to forward to the City of McKinney a total of **\$17,560.00** of the JAG Award funds which will be used by the City of McKinney to purchase mass casualty incident bags to be placed in Patrol Supervisor vehicles to be deployed in the event of a mass casualty event.

3. City of Plano agrees to forward to the City of Frisco a total of **\$11,989.00** of the JAG Award funds which will be used by the City of Frisco to purchase one (1) safekeeper cold evidence refrigerator for blood evidence storage and six (6) mass casualty response kits to be deployed in the event of a mass casualty event.

4. City of Plano agrees to keep the remaining total of **\$27,670.00** of the JAG Award funds which will be used by the City of Plano to purchase precision rifles and accessories for the Plano Police Department Snipers.

5. Nothing in the performance of this Agreement shall impose any liability for claims against any of the Parties other than claims for which liability may be imposed by the Texas Tort Claims Act.

6. Each Party to this Agreement will be responsible for its own actions in providing services under this Agreement and shall not be liable for any civil liability that may arise from the furnishing of the services by the other party.

7. The Parties to this Agreement do not intend for any third party to obtain a right by virtue of this Agreement.

8. By entering into this Agreement, the Parties do not intend to create any obligations express or implied other than those set out herein.



RESOLUTION NO. 2023-09-114 (R)

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, AUTHORIZING THE CITY MANAGER ENTER INTO AN INTERLOCAL AGREEMENT AND MEMORANDUM OF UNDERSTANDING BETWEEN THE CITY OF PLANO, THE CITY OF MCKINNEY, THE CITY OF FRISCO, AND COLLIN COUNTY FOR THE APPLICATION AND ADMINISTRATION OF THE DEPARTMENT OF JUSTICE 2023 BYRNE JUSTICE ASSISTANCE GRANT, AND DESIGNATING THE CITY MANAGER, OR HIS DESIGNEE, AS THE OFFICIAL REPRESENTATIVE OF THE CITY OF MCKINNEY IN MATTERS RELATING TO THE PROGRAM

WHEREAS, the City Council, recognizes the need for the application for and acceptance of federal funds, allocated to the City of McKinney to assist the McKinney Police Department in enhancing public safety and reducing crime in the City of McKinney; and

WHEREAS, the Justice Assistance Grant funds are allocated by the U.S. Department of Justice, to be shared between the City of Plano, the City of McKinney, the City of Frisco, and Collin County to enhance public safety and reduce crime.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MCKINNEY, TEXAS, THAT:


Section 1. The City Council hereby authorizes the City Manager, or his designee, to apply for and accept, if awarded, the U.S. Department of Justice 2023 Justice Assistance Grant, and administer all matters related to acceptance of said grant.

Section 2. The City Council, hereby authorizes the City Manager, or his designee, to enter into an Interlocal Agreement (Exhibit A) and Memorandum of Understanding (Exhibit B) with Collin County, the City of Frisco, and the City of Plano for the disbursement of the grant funds.

Section 3. This Resolution shall take effect immediately from and after the date of passage and it is so resolved.
