Fleet customers must have an active and in good standing Ford Fleet Care account to be eligible. Upon claiming, The Ford Fleet Care team will be sent funds in the amount of your claimed earnings as a credit which can be applied towards a portion or all of your billing account statement.

REWARDS CARDS

Reloadable Mastercard[®] issued within 10-15 business days after claiming and can be used wherever Mastercard is accepted. Government Fleets are ineligible for a Rewards Card as a payment option.
