2. General Discussion Items:

a. AI-54815 Emergency Management exercise update, Administrative Services.

Jason Browning, Fire Marshal Emergency Manager, updated the Court on the upcoming Emergency Management exercise. The Collin County Fire Marshal's department collaborated with TEEX (Texas A&M Engineering Extension Service) to come up with scenario based functional exercises which are designed to exercise the County's capability during a disaster. A tabletop exercise was performed at Myers Park; the scenario was based on a long track tornado on the southern tip of Collin County. After the completion of the tabletop exercise, TEEX came back with comments that led Mr. Browning and his staff into an EOC (Emergency Operation Center) functional exercise. There was discussions held on how to procure things in an event of a disaster, such as clearing roads, extra tools or equipment, how those

purchases are made, and the process of making those purchases. Mr. Browning said these two exercises are leading up to the full-scale infield exercise that is expected to be ran the first week of December 2023.

Commissioner Fletcher asked Mr. Browning if other disasters are incorporated into these types of exercises, he confirmed there are components from different disasters included. Judge Hill said he attended a meeting in January of this year where ideas were discussed in relation to the full-scale in field exercise. After reaching out to TEEX a decision was made to focus on the more common disasters we see in our area, tornados. (Time: 1:38 p.m.)

3. Executive Session Items:

The Court did not recess into Executive Session.

Public Comments not related to an item on the Agenda.

Joshua Murray, Lavon, recognized Judge Hill and his efforts in putting together an Emergency Management response exercise. After the completion of his comments last week in regards to the County's inability to recruit, train, and retain employees, Commissioner Hale indicated the Court does this once a year during budget workshop, and also indicated the Commissioners Court does not want to dictate what could and could not be done with the County and Elected Officials staff. Mr. Murray said he understands the Court meets once a year and discusses the budget, but what the Elected Officials present to the Court during that time is not always approved. Mr. Murray said he is asking for an operational plan that enables Collin County to recruit, train, and retain employees. If there is approval to add additional staff for a department to operate effectively, but the pay, benefits, and morale not increased, nothing has been done aside from authorizing more positions that cannot be fulfilled. This is why authorized positions continue to increase but the number of people on the workforce remains the same.

Judge Hill asked Bill Bilyeu, County Administrator, if since 2013 when he joined the Commissioners Court, there have been any budget workshops where the amount of staff and wages for current and future employees have not been increased. Mr. Bilyeu confirmed there has not been a budget workshop where additional staffing and wages have not been increased. Judge Hill stated the comments from the previous speaker are false and unfortunately there is a recurring pattern of false comments and incorrect information are heard from the speaker week after week.

Barbara Lyke, Wylie, spoke on behalf of her neighbors, Debbie and Rhett Windham. Ms. Windham commended the Collin County SO (Sheriff's Office), specifically Deputy Chris Rothblatt and Deputy Justin Golson for the invaluable help they provided their family in December of 2022. Debbie's sister, Myra, had been showing signs of Alzheimer's since 2018 and was progressively getting worse to the point of wandering multiple times throughout the day. Debbie had exhausted every avenue to provide her sister

with the help she needed. In December of 2022, Myra went out on an attempt to walk 90 miles back to her house. Debbie called the SO and they were quick to respond, kind, gentle, compassionate, professional, and knew exactly how to handle the situation. The SO provided the help Debbie and her family needed. The officers could have picked her up, dropped her off, and gone on their way, but because of their suggestions and actions, Myra was taken to the hospital and evaluated. Within a few days she was placed in a memory care facility where she is safe and doing well. Myra's family will be forever grateful for the help the deputies provided.

Judge Hill thanked Ms. Lyke for sharing her comments with the Court and asked Chief Langan on behalf of the Commissioners Court to express their gratitude to the deputies mentioned. (Time: 1:46p.m.)

There being no further business of the Court, Judge Hill adjourned the meeting at 1:46p.m.
