Dear Voter Registration Official,

The voter registration activity statements for Fiscal Year 2023 are now available online. Please log into the Elections Management and Reporting System to view the statement. Once logged into the system, select the "Chapter 19 and VR Postage Funding" link, click on "Chapter 19" and then click on "Activity Statement" to review and certify the data. Upon certification, your 2023 Chapter 19 funding will be made available effective June 1, 2023. The voter registration activity statements must be certified to the Secretary of State **no later than May 15, 2023.**

The data used to populate the Activity Statement was pulled from the TEAM system using the NVRA Application and NVRA Status Reports.

Section 19.002 states:

Issuance of direct deposit payments by Secretary of State's office (a) Each registrar is entitled to receive the sum of the following amounts:

- (1) 25 cents multiplied by the number of initial registrations certified under Section 19.001(a)(1);
- (2) 40 cents multiplied by the number of canceled registrations certified under Section 19.001(a)(2);
- (3) 40 cents multiplied by the number of updated registrations under Section 19.001(a)(3); and

Changes for which a county is eligible for reimbursement are: address or name changes submitted by the voter through a change form, Texas Online application or other written means; address or name changes submitted by a voter through

a voter registration application or certificate; address or name completion of a state point of residence form; or completion of a confirmation response form that result in an address or name change. These are indicated using an Approve 12 Change Code when updating the voter application. A county is also eligible for reimbursement for any change of address due to 911 standardization. Changes that are not reimbursable are: changes made to a voter's registration record to correct an erroneous precinct number; clerical corrections; correcting jurisdictional information; or changes due to redistricting, misspellings or birth dates.

A reimbursement of 40 cents is provided for cancellations under Section 16.031(a)(1) or Section 16.033 and 16.0332. The reimbursement does not include cancellations based on: 1) receipt of abstract of death; 2) final judgment of the voter's mental incompetence; 3) notice of a voter's disqualification to be registered as a result of an election contest; 4) conviction of a felony. Please note, however, that often times inaccurate or incomplete data is received on a felon. We recommend that all felony notifications be sent a notice of examination, rather than immediately canceling the voter. By canceling the voter under the notice of examination, this qualifies your office for a reimbursable cancellation under Section 16.033); 5) notice from a voter registrar in another state that a Texas voter has reregistered; 6) notice from the Secretary of State that the voter is a duplicate, based on driver's license or social security information; and, 7) at a voter's request to be cancelled.
