The **DEPARTMENT OF STATE HEALTH SERVICES** (“DSHS” or “System Agency”) and **COLLIN COUNTY** (“Grantee”), each a “Party” and collectively the “Parties” to that certain Detection and Mitigation of Infectious Disease in Confinement Facilities Grant Program agreement, denominated DSHS Contract No. HHS001193700005 and effective December 6, 2022 (“Contract”), now desire to amend the Contract.

WHEREAS, the Parties have chosen to exercise their option to amend their agreement in accordance with Section 11.1 of Attachment D to the Contract, Health and Human Services (HHS) Uniform Terms and Conditions (Grant, Version 3.2); and

WHEREAS, the Parties desire to revise the Budget by redistributing funds among the budget categories with no change to the total Contract amount.

NOW, THEREFORE, the Parties hereby amend and modify the Contract as follows:

1. **ATTACHMENT B-1** of the Contract, **BUDGET (AMENDED MARCH 2023)**, is hereby deleted in its entirety and replaced with **ATTACHMENT B-2, REVISED BUDGET**.
2. This Amendment No. 2 shall be effective as of the date last signed below.
3. Except as amended and modified by this Amendment No. 2, all terms and conditions of the Contract shall remain in full force and effect.
4. Any further revisions to the Contract shall be by written agreement of the Parties.
