b AI-54875 Jail Expansion/Construction Update, Administrative Services.

Bill Burke, Construction and Projects, updated the Court on the Jail Expansion and the Medical/Mental Health Addition construction. Mr. Burke said the Jail Expansion Book-In/Orientation Housing contains 180 beds, bringing the total bed count to 1,478. This will double the Book-in capacity to accommodate the expected volume through 2044. Construction is expected to be completed by May 2024 and open for use in July 2024. He said the building has shell space that can be built out to add an additional 34 Female Housing beds when funding becomes available. The first bid for the Medical/Mental Health Addition came in \$15 million dollars over budget, resulting in the removal of a wing of the building in the current bid. The second bid is expected to be received in mid-December and construction to start in February or March 2024. ARPA (American Rescue Plan Act) requires the building to be completed prior to December 31, 2026. After the removal of the wing, this phase will add 119 beds, bringing the total beds to 1,597. The Bond Election happening this November has funding included to finish out shell space with an additional 174 beds.

Commissioner Hale asked if the other projects are being done concurrently. Mr. Burke said they are currently waiting on the equipment for the new Central Plan, but expects to receive it by May 2024. The new build will be able to function efficiently on the current Central Plan. (Time: 1:39 p.m.)

d AI-33858 Regional Transportation Council monthly update, Commissioner, Precinct 4.

Commissioner Webb updated the Court on the discussions that took place during the recent RTC (Regional Transportation Council) monthly meeting. TTC (Texas Transportation Commission) proposed a new rule, which gives a project two years to be obligated and moved into construction or the allocated funds will be taken away. Under the current federal and state laws, the MPO (Metropolitan Planning Organization) and TxDOT (Texas Department of Transportation) have to agree on projects within the MPO's area. Commissioner Webb said one of the main concerns for the new proposed rule, is if an agreement cannot be made, funding will be taken away, thus causing major issues for our area. The RTC discussed on how to respond to the proposed rule and the implications associated. The Court had a brief discussion on the possible opportunities that could come out of the new proposed rule.

The RTC also discussed the major increase of fatalities in Collin County. The fatality rates are currently up 51% from 2021 to 2022. The main contributing factors are speed, failure to yield, and intoxication. He discussed the primary locations of the crashes including, US 75, SH 289, US 380, SH 78, and SH 121. The current data will be compared to the previous year's traffic volumes to see if the increase of fatality rates is out of line or if there are road areas that have a higher fatality rate. Commissioner Webb said due to the contributing factors an increase of law enforcement and an educational campaign should be considered. (Time: 2:02 p.m.)

Public Comments not related to an item on the Agenda.

Debbie Lindstrom, McKinney, spoke on the vulnerabilities associated with using electronic voting machines. The CDF (Citizens Defending Freedom) was made aware of a vulnerability and inquired about it during the public logic and accuracy test on October 12th, 2023. During this public event, CDF asked Kaleb Breaux, Collin County Deputy Elections Administrator, if he would allow a security test on the election network that would not affect the machines. An address was provided to enter into a web browser on the server, if it responded with information, it would prove there is an open backdoor on the server. The CDF intended for Mr. Breaux to receive buy-in from the IT (Information Technology) department that the command would not hurt the system; however, the IT department did not answer the question, ignored the request, and answered a different question. Ms. Lindstrom read an email she received from Mr. Breaux, which said preforming the task would be irrelevant due to the servers being air gaped and not communicating with any outside networks. She said it is not completely irrelevant because if the vulnerability is active on the server, any computer in the election network can connect to the address on the server. This shows a disregard for basic IT security and does not provide any confidence that our election department is serious about network security.

Tara Schulte, McKinney, continued the conversation on network vulnerability, and read an email from a cyber-expert responding to Kaleb Breaux's response to Ms. Lindstrom. She asked the Court why the test was not being ran and if they would consider having an elections committee that would meet regularly to discuss these topics.

Judy Dishong, Plano, spoke on the recent actions and news regarding Ken Paxton, Texas Attorney General. She said she wants the government to do the work of the people, which is not happening. Something needs to be done to reverse the trend. (Time: 2:40 p.m.)

There being no further business of the Court, Commissioner Webb adjourned the meeting at 2:40 p.m.
