The **Veterans Treatment Court Innovations Program** is designed to help new or existing veterans treatment courts enhance their programs in one or more of the following areas:

- Risk assessment
- Need assessment
- Data collection and research evaluation
- Social connectedness programming
- Case management and supervision

Justice for Vets will award grants of up to \$67,742 each for a grant period of up to 12 months. The grant application process has been **simplified and streamlined**: Simply enter your court's contact information; upload your proposal, time/task plan, and budget documents; and answer three questions about federal grant funding compliance.
