Judge Hill reconvened the meeting at 2:22 p.m. No action was taken during Executive Session.

Public Comments not related to an item on the Agenda.

Joshua Murray, Lavon, said he has been attending the Commissioners Court meetings for three years and has spent hours speaking to the Court. Last week during the December 4th Commissioners Court meeting, Judge Hill questioned Mr. Murray's integrity. Mr. Murray said part of the reason he started attending the

meetings in 2021 was due to Collin County's Detention Officer pay being too low and the inability to recruit, train and retain staff to fill those positions. Last week he indicated certain budget issues that need to be addressed more frequently than once a year. However, his microphone was shut off by Judge Hill. Since Mr. Murray started attending the Commissioners Court meetings there have been multiple incidents where Judge Hill has infringed on his first amendment right. (Time: 2:25 p.m.)

Chuck Reynolds, McKinney, said America just had the anniversary on the Attack on Pearl Harbor, a tragedy that may have been prevented with more attention to the signs at the time. Over the last three years, we have witnessed unprecedented misinformation, censorship, deceptions, and injustice. There have been numerous election problems in counties across our nation. The 2024 elections might be the American citizen's last opportunity to be heard and properly represented. He asked the Court to consider three factors of the electronic voting systems that prevent the election process from being secure and safe. They are proprietary code, air gap, and paper ballots created by electronic marking devices are not reasonably verifiable and audited. (Time: 2:28 p.m.)

There being no further business of the Court, Judge Hill adjourned the meeting at 2:29 p.m.
