They also discussed the impacts of the impeachment vote as well as education policy and vouchers. She said the boarder was the number one issue in this upcoming election. Commissioner Hale mentioned the fantastic growth in North Texas and how quickly we recovered after COVID and ahead of the rest of the state.. (Time: 1:52 p.m.)

Commissioner Webb updated the Court on the most recent RTC (Regional Transportation Council) meeting. He said they were only able to get through three agenda items. The primary one was the Strategic Transportation Funding Program, which was to approve projects that have been pushed around for years. One project was \$30 million for traffic signal equipment standardization across the DFW (Dallas Fort Worth) areas. Another project being considered was improvements for the intersection at Frankford and the DNT (Dallas North Toll Road) . This discussion lead to a disagreement on whether this item should be approved or held. Ultimately, the item was approved. Commissioner Webb said the outline of the Priority Climate Action Plan was also approved because we are in a "severe" classification status for the region. (Time: 1:56 p.m.)
