### **Public Comments not related to an item on the Agenda.**


Chuck Reynolds, McKinney, shared his concern over the use of Ballet Marking Devices (BMD) instead of hand-marked ballots. He stated around 10% of voters verify their selections on BMDs as opposed to hand-marked ballots which are verified by voters 100% of the time. He said an election that uses BMDs is not a safe or transparent election. Mr. Reynolds asked the Court to protect the county by supporting a safe and transparent election through the use of hand-marked ballots. (Time: 1:35 p.m.)

Debbie Lindstrom, McKinney, was concerned about the sanctity of the secret ballot. She said this issue was addressed in the recently released Emergency Opinion and Advisory by the Attorney General and Secretary of State who verified ballots are not being kept secret. Ms. Lindstrom urged the Court to discontinue the current countywide voting system which has failed to preserve the secrecy of voters' ballots. She asked for the use of pre-printed, sequentially numbered, hand-marked ballots along with precinct voting in the upcoming election. (Time: 1:38 p.m.)


There being no further business of the Court, Judge Hill adjourned the meeting at 1:39 p.m.

Susan Fletcher, Commissioner, Pct 1




