### **COMMISSIONERS COURT BUSINESS:**

Public comments related to an item on the Agenda

Chuck Reynolds, McKinney, spoke in opposition to the elections portion of AI-55867. Mr. Reynolds stated the agenda item appeared to recommend the purchase of more election electronics, taking elections online. In his opinion, taking that route would go against the wants of the County citizens, as evidenced by several County Precinct Chairs and numerous public speakers who have spoken out in opposition to electronic voting in 2022, 2023 and 2024. Additionally, Mr. Reynolds addressed the Court regarding the use of BMDs (Ballot Marking Device). Only around 10% of citizens verify their BMD paper ballot. Mr. Reynolds stated hand-marked paper ballots are up to 10 times safer because they are 100% voter verified. The citizens must have their votes protected. (Time 1:35 p.m.)

Debbie Lindstrom, Citizens Defending Freedom, spoke in opposition to AI-55867, related to the County's involvement with The Texas Conference of Urban Counties as well as countywide voting. Ms. Lindstrom strongly discouraged taking the recommendations from this conference to promote the countywide voting program and increase funding for election electronic equipment. Ms. Lindstrom stated that the current system fails to provide secrecy, meet EAC (Election Assistance Commission) standards, and produce auditable voting records. She believed the recommendation from the Urban Counties Conference naïve and encouraged the Court to disregard them. Ms. Lindstrom further noted how countywide voting would negatively affect a comprehensive audit and maintain transparency. A solution is needed which preserves both voter secrecy and the ability to provide comprehensive audit results. Ms. Lindstrom believes the solution to this issue is precinct level voting. (Time 1:38 p.m.)

Lee Moore submitted a blue card but did not appear before the Court to speak.

2. General Discussion Items:

Presentation, discussion and any action regarding:

Discussion item 2c pulled by Commissioner Hale for future court proceedings.

a. AI-56242 Law Enforcement Compensation Presentation, Human Resources.

Cynthia Jacobson, Human Resources, provided a PowerPoint presentation on the wages for law enforcement in preparation for the upcoming annual budget review. The presentation included the following positions: dispatchers, detention officers, court officers, jail sergeants, deputy sheriffs, sergeants, lieutenants, captains, deputy constables and deputy fire marshals. The data included comparisons with nearby cities and counties as well as organizational changes within the County over the past year. The benchmark positions used in the analysis were matched with other cities and counties. Ms. Jacobson noted Collin County's overall turnover rate improved across the board from last year. While the number of people leaving decreased, the number leaving specifically for other job offers increased from 29% to 43%. Reasons for leaving varied based upon exit interviews and included other job offers, leaving workforce, and unmet expectations for higher starting salaries. Some positions have higher turnover than others such as in the jail where over half of detention officers leave within the first two years. Other positions such as court officers and deputy sheriffs have more longevity.

Commissioner Fletcher asked if there was data on how many individuals left for other law enforcement job offers, as opposed to those leaving the profession entirely. Ms. Jacobson confirmed that employees left for city or Independent School District positions. She said four detention officers, one deputy sheriff, and one dispatcher left to work for other cities.

Collin County will continue to participate in the Supplemental Pay Programs, excluding the Retention Program when ended in 2023. Ms. Jacobson said statistically the Retention Program was not successful for the County so the Range Master Program was added in 2023. Collin County will continue to offer

Special Teams Pay. Collin County was committed to a huge salary increase for law enforcement in FY2024. These wage movements totaled approximately \$4 million from less than \$2 million spent the year prior. Wage movements have kept Collin equitable for hiring purposes.

Commissioner Hale asked for clarification on the reasons the deputy sheriffs gave for leaving their positions. Ms. Jacobson confirmed only one deputy sheriff indicated he went to work for another city. (Time 2:02 p.m.)

### b. AI-55867 Conference of Urban Counties Update, Commissioner, Precinct 1.

Commissioner Fletcher attended the CUC (Conference on Urban Counties) and provided the Court with relevant updates. Policies on taxpayer funded lobbying, elections and hand-counting were discussed. She added there were potential bill which would do away with election administrators. Commissioner Fletcher assured Ms. Lindstrom that the CUC's primary focus was to advocate for local governmental control. The CUC has strived to reduce unfunded mandates, which increase property taxes. There was a discussion about House changes and what could be expected as a result. Another special meeting will be held in October for the specific purpose of ratifying a new policy document. Fire districts were a brief point of discussion, but it was determined the topic would be held to see where the dialogue of annexation and controlling areas outside of municipal borders concluded. The TAC (Texas Association of Counties) will hold their legislative conference in Austin in August with a focus on Senate Bill 4.

The membership meeting considered the upcoming Speaker's race held by two former state representatives, Rep. Jim Keffer and Rep. Myra Crownover. (Time 2:08 p. m.)
