On Monday, July 22, 2024, the Commissioners Court of Collin County, Texas, met in Regular Session in the Commissioners Courtroom, Jack Hatchell Collin County Administration Building, 4th Floor, 2300 Bloomdale Road, City of McKinney, Texas, with the following members present, and participating, to wit:

Judge Hill led the Invocation. Commissioner Hale led the Pledge of Allegiance. Commissioner Williams led the Pledge of Allegiance to the Texas Flag.

Judge Hill called to order the meeting of the <u>Collin County Commissioners Court</u> at 1:30 p.m. The meeting was adjourned at 3:38 p.m.

President Hill called to order the meeting of the <u>Collin County Health Care Foundation</u> at 3:38 p.m. The meeting was adjourned at 3:38 p.m.

Judge Hill opened court by recognizing Collin County IT staff (Information Technology) for their hard work in dealing with the nationwide CrowdStrike event last week. System issues were identified and reported to IT on Friday around 1:15 a.m. By 8:00 a.m., 90% of systems were back up and functioning normally. By 9:00 a.m., IT staff were dispatched to various locations throughout the county to resolve remaining issues. Their diligent efforts resulted in minimal interruption of service to our customers. Public comments related to an item on the Agenda.

Joshua Murray, Lavon, commented on AI-56193 related to overtime compensation. He asked the Court and HR (Human Resources) to consider differentiating between forced overtime pay and voluntary overtime pay as this would provide insight to current and future departmental staffing needs. (Time 1:36 p.m.)

Chuck Reynolds, McKinney, expressed his concern over security risks caused by election electronics as evidenced by the recent CrowdStrike event. Collin County citizens have formally communicated to the Court their distrust of election electronics and concerns for election security through community resolutions and public comments in Commissioners Court. Mr. Reynolds has repeatedly asked the Court to use hand-counted, hand-marked ballots as a means to preserve the voter's intent in the upcoming election and urged the Court to provide citizens with a detailed public explanation if they opted to use BMDs (Ballot Marking Device) instead of hand counted, hand marked ballots. Commissioner Webb shared his concerns over approving this item simply because a credit was available on this contract. The requested amendment included items not previously approved as part of the Audio Visual Upgrade budget. Commissioner Webb felt approval on this request would set a precedent for future requests by judges for items which should be purchased through the technology fund for the district courts.

Judge Hill asked Michelle Charnoski, Purchasing, for clarification on the existing credit and how approving or rejecting the request would affect it. She stated an approval would reduce the existing credit of \$34,000 by the requested amount of \$21,275. If the requested upgrade was not approved, then the change order would be voided and the contract would revert to the last approved invoice. The \$34,000 credit would remain unaffected.

Linda Riggs, Auditor, said the standard process for this scenario was to have the credit applied towards the next invoice. A refund would occur if a credit balance remained after the project's completion. (Time 1:45 p.m.)

2. General Discussion Items:

Presentation, discussion and any action regarding:

a. <u>AI-56040</u> Award of Jail and Personal Inmate Supplies (IFB No. 2024-174) to various vendors, Sheriff. Shay Purser, Purchasing, presented awards to several vendors.

Michelle Charnoski, Purchasing, said a formal bid for jail and personal inmate supplies was conducted with three line items resulting in a tie. A drawing of lots was done; the results were as follows: Line item two for bedding, towels, and washcloths: Primary award to Victory Supply LLC; Secondary award to Phoenix Supply LLC

Line item one for inmate clothing socks: Primary award to Bob Barker Company Inc.; Secondary award to Victory Supply LLC

Line item 105 for miscellaneous supplies, deodorant: Secondary award to Phoenix Supply LLC; Tertiary award to Victory Supply LLC (Time 1:49 p.m.)

b. AI-56193 Overtime Compensation, Human Resources.

Cynthia Jacobson, Human Resources, shared her presentation on Overtime Compensation for the period of January 2024 – June 2024. Her presentation included overtime wages and hours broken down by department. The largest amount of overtime incurred was attributed to the SO (Sheriff's Office). The amount budgeted for SO overtime was set at \$223,000 which could be offset by grants or vacant positions.

In response to questions from the Court, Ms. Jacobson explained how various payroll codes could be used to track and categorize specific overtime usage, the limitations of those codes, as well as how staffing levels impacted the amount of overtime incurred by the SO.

Further discussion led to questions over the reason for increased Housing overtime in spite of the recent staff increase authorized for the SO to cover training requirements as well as PTO accruals and usage. Ms. Jacobson acknowledged increased staffing levels limited the amount of overtime which historically had been offset by vacant positions and additional information was needed from the SO explaining the reason for variance between expected overtime versus actual overtime incurred.

Commissioner Webb asked Ms. Jacobson if the Juvenile Department experienced similar overtime issues as the SO. Ms. Jacobson said this was not the case as overtime was not being used by the Juvenile Department until they had reached critical staffing shortages. The department head indicated future overtime would not be needed unless staffing shortages again became a critical issue.

Judge Hill recommended holding further discussions until Budget Workshop when Sheriff Skinner would be available to provide additional information on his department's overtime accruals. Additionally, consideration for a policy to rein in overtime would be done at Budget Workshop.

The Court discussed the proposed court order to allow the County Judge to authorize overtime compensation. The proposed court order was amended to begin on July 1, 2024 and expire at the finalization of the FY2025 budget. (Time 2:29 p.m.)

c. AI-56243 2024 Benefits Presentation, Human Resources.

Cynthia Jacobson, Human Resources, provided a presentation on benefit costs. This included information on 2023 average premium costs, catastrophic and stop loss claims, top diagnosis categories, major cost drivers, and increased pharmacy costs for both specialty and non-specialty medications.

Ms. Jacobson highlighted the need to address ER (emergency room) copays in the next fiscal year. Average costs for an urgent care visit are \$175 compared to average ER costs of \$3,075. To encourage employees to reserve using the ER for true emergencies, Ms. Jacobson recommended increasing the ER copay from \$500 to \$750 in FY2025.

This change would be in line with previous percentage-based employee costs as \$750 is approximately 25% of current ER costs. This copay would be waived if the patient was admitted to the hospital.

Ms. Jacobson provided cost comparisons for medical plan deductibles, primary care physician and specialist copays, coinsurance percentages, dental plan deductibles, as well as statistics and demographic information on medical plan coverage for employees, spouses and families.

She recommended making changes to insurance premiums and adding a third person for deductible and out-of-pocket maximum. Another item mentioned for Court consideration was reinstating weight loss surgery as part of the benefits offered. Ms. Jacobson explained how rising costs of weight loss drugs and significantly lowered costs for weight loss surgery make either a possible option for employees who have been identified as being pre-diabetic with a medically documented need to lose weight. d. AI-56244 2024 TCDRS Presentation, Human Resources.

Ms. Jacobson summarized current retirement benefits including employee deposit rates, matching rates, vesting period and retirement eligibility requirements. She noted how the County compared in these areas with various surrounding cities and counties. She also provided rate of return comparisons over five and ten year periods for TCDRS (Texas County & District Retirement System) and TMRS (Texas Municipal Retirement System). The items she provided for Court consideration going into Budget Workshop included employer contribution rate, payment of any lump sum contribution for unfunded liability and determination of any retiree cost of living adjustment. (Time 3:35 p.m.)

e. AI-55905 Regional Transportation Council monthly update, Commissioner, Precinct 4.

Commissioner Webb shared a noteworthy item from a recent RTC (Regional Transportation Council) meeting. He said the Texas Transportation Commission completed the first draft of their ten year UTP (Unified Transportation Plan) which outlined the development of transportation work in Texas. The UTP included allocating \$740M of Category 12 funds towards Collin's Spur 399 - US 380 project. These funds are in addition to monies already allocated for right-of-way construction and engineering costs. The additional funding would help minimize project delays and assist with costs related to service roads in the "McKinney Loop". (Time 3:38pm)
