### **COMMISSIONERS COURT BUSINESS:**

#### Public comments related to an item on the Agenda.

Mark Brugge, Fairview, commented on AI-56440 related to the amendment to the Collin County Overtime Policy. Mr. Brugge shared his concerns stating the County's law enforcement officers have not been given the resources needed in order to adequately protect Collin County. He urged the Court to show their support for law enforcement through better funding. (Time 1:34 p.m.)

Joshua Murray, Lavon, spoke on AI-56367 pertaining to the Turnover Report and the projected tax rate for FY2025. Mr. Murray expressed dissatisfaction with the proposed tax rate as the increase was not sufficient to account for inflation, fill the needs of law enforcement, or support essential services. He stated all departments, especially the Sheriff's Office, needed better resources and suggested raising the tax rate enough to fill those needs in FY2025 and in the years to come. (Time 1:37 p.m.)

Debbie Lindstrom, McKinney, spoke in opposition to AI-56356 the purchase of 100 VoteSafe field system licenses from VOTECH in the amount of \$80,000. While she understood the legal requirement to utilize countywide voting during early voting due to State mandates, she believed countywide voting must be eliminated and replaced with precinct level voting. Ms. Lindstrom stated precinct level voting offered advantages in simplicity, auditability, and voter confidentiality. Ms. Lindstrom was also concerned with the cybersecurity of electronic internet-connected poll books. The recent Crowdstrike incident raised added concerns about election integrity and security. She recommended advanced planning and preparations for poll workers to deal with a possible internet outage.

In addition, she said Collin County was out of compliance with Texas Election Code Sec. 42.006 which was intended to protect ballot secrecy. This code requires voting precincts to contain between 100 and 5,000 registered voters. As of June 23, 2024, nine precincts fell below the stated limit and 11 exceeded it. She requested a follow-up email from the Court within one week regarding this election code violation. (Time 1:40 p.m.)

Judge Hill introduced an amendment to the Collin County Overtime Policy submitted by Commissioner Duncan Webb. He asked Yoon Kim, County Administrator, for clarification as to when the amended policy would go into effect.

Mr. Kim said the amendment would go into effect today if passed today. He recommended the policy go into effect with FY2025 on October 1, 2024 based on the overtime discussions held during Budget Workshop. Since the Sheriff's Office overtime budget of \$233,000 had already been exceeded for FY2024, the practical application of the policy would be of more benefit in FY2025.

Mr. Kim asked the Court to provide clarification on the overtime approval process for the remainder of FY2024 until the new policy went into effect. The discussion on the proposed overtime policy also included the need for a motion to address overtime accrued by select departments which did not have overtime funds left in their overtime budget line items for the remainder of the current fiscal year.

Ms. Arris explained the plan to pay remaining overtime through end of FY2024 for departments in this situation, namely the Sheriff's Office. Any funds for current vacancies would be moved over to the overtime line item on that department's budget. This would offset the shortage in overtime funds through the end of the current fiscal year. Departments without an overtime line item would need to appear before the Court to request the use and transfer of funds from their budget to pay for overtime.

After a lengthy discussion by the Court with Mr. Kim, Monika Arris, Budget, and Cynthia Jacobson, Human Resources regarding the funding and ministerial issues surrounding overtime accruals, approvals, and budgets, the language on the proposed overtime policy was amended to state:

"...If the elected official or department head has funding available in the overtime line item, he or she may approve overtime, and payroll will pay overtime on the next pay period...Court members will receive a monthly update on authorized overtime."

A motion was made to adopt this overtime with the amended language to be effective October 1, 2024. (Time 2:01 p.m.)

Judge Hill shared the projections on anticipated population and employment growth from now through 2050-2060 which were presented during the NCTCOG (North Texas Central Council of Governments) meeting. The current population of the North Central Texas region is approximately 8 million people with the potential to exceed 12 million by 2050. Employment numbers are expected to increase from 5.8 million jobs to 8.7 million jobs by the same point in time. (Time 2:10 p.m.)

### 3. Executive Session Items:

The Court did not recess into Executive Session.

### Public Comments not related to an item on the Agenda.

Chuck Reynolds, McKinney, expressed his concern over security risks posed by election electronics. He outlined eight points of comparison to highlight how hand marked ballots were preferable over the use of BMDs (Ballot Marking Devices). He said hand marked ballots eliminated dangerous and unnecessary translations, did not pose an electronic security risk, are emergency capable, and more. He concluded by saying BMD ballots were not trustworthy. (Time 2:14 p.m.)

Lee Moore, Fairview, continued Debbie Lindstrom's comments on the use of countywide election voting. Ms. Moore was concerned with the need for voter privacy, ballot secrecy, and the ability to make an election auditable through precinct level voting. She said current BMDs do not preserve the voter's intent and she urged the Court to protect the votes through the use of hand marked ballots. She further shared how political parties in Georgia have called on the Election Board to move to hand marked paper ballots due to cybersecurity risks as evidenced by the recent CrowdStrike incident. (Time 2:18 p.m.)

There being no further business of the Court, Judge Hill adjourned the meeting at 2:18 p.m.
