RE: Health Services Agreement – Formerly Proposed Renewal and New Intake Expansion

Greetings Mr. Alley:

I hope this letter finds you well. Wellpath is pleased to be your provider of patient healthcare services, and we are excited to move into another year of delivery quality healthcare for the patients of Collin County.

Contract Renewal

We understand that the County has verbally agreed to our proposed renewal terms for the contract year, effective October 1, 2024. Our contract renewal included the following adjustments to the compensation and staffing matrix total:

- 5.26% Consumer Price Index ("CPI") adjustment for the Adult and Juvenile facilities.
- Additional 8.45 FTE (338 hours) of staffing revising FTE total to 82.05.

Based on this verbal agreement, the following adjustments to the contract detailed below shall be based on the total proposed contract amount from our renewal of **\$14,025,198.95** annually, effective October 1, 2024, or \$13,315,684.94 for the Adut facility, and \$709,514.01 annually for the Juvenile facility.

New Intake Expansion

Based on previous discussions between Collin County and Wellpath, we understand that the site is expanding the current intake to accommodate the growing patient population. Based on these discussions, we propose adding the following staffing adjustments to the staffing matrix and compensation from our renewal, effective October 1, 2024:

- Add 4.20 FTE (168 hours) of Nurse Practitioner/ PA
- Add 0.90 FTE (36 hours) of Sick Call/ Detox/ MAT RN
- Add 12.60 FTE (504 hours) of Licensed Vocational Nurse (LVN)
- Add 1.00 FTE (40 hours) of Medical Records Clerk (MRC)
- Add 4.20 FTE (168 hours) of Registered Nurse (RN)
- Remove 4.20 FTE (168 hours) of Licensed Vocational Nurse

The proposed staffing additions would strengthen our ability to retain and support a stable, competent staff providing consistent care for the new intake expansion. The following table presents the associated monthly and annual cost to implement the proposed staffing adjustments stated above:

ADP Increase - Adult

We understand that the patient population and the necessary staffing to accommodate this influx continues to rise, therefore, Wellpath proposes increasing the Average Daily Population (ADP) for Adult inmates from 992 to 1,330, an increase of 339 ADP. The total contracted ADP following this adjustment would be 1,330 for Adult and 85 for Juvenile, totaling an ADP of 1,415.

Detailed Overview - Adult Expansion

The following table presents the associated monthly and annual cost adjustments to the Adult contract based on the proposed staffing and contract adjustments:

Total Contract Price

The compensation total for Juvenile services shall remain unchanged from the renewal at \$709,514.01 annually. The total proposed contract amount for Adult and Juvenile combined, effective October 1, 2024, would be \$17,511,559.15 annually, or \$1,459,296.60 monthly, should the County accept.
