

- 7. Missing Limbs (Non-Ambulatory such as crutches, cane or wheelchair bound)
- 8. Pregnant Females
- 9. Excessive Open Sores, Cuts or Other Wounds
- 10. Prisoners taking blood thinners
- 11.65 years of age or older
- 12. Inmates weighing more than 280lbs may require an additional charge for transport.

Please note that US Corrections reserves the right to refuse any transport.
