### YOU ARE DIRECTED TO MAKE THE FOLLOWING MODIFICATION TO THIS CONTRACT

In accordance with the Food Services Agreement, Exhibit A, §I. Price Per Meal, contract price is hereby increased by 4.1 % for adult inmate meals, sack lunches, staff meals and 7.5% for juvenile meals, effective October 16, 2024.

The current meal cost per inmate at the adult detention facilities will increase 4.1% from \$2.1870 to \$2.2767 each.

The current meal cost per juvenile at the juvenile detention facilities will increase 7.5% from \$2.3770 to \$2.5553 each.

The current meal cost per sack lunch at the adult detention facilities and juvenile facilities will increase 4.1% from \$2.4500 to \$2.5505 each.

The current meal cost per staff meal will increase 4.1% from \$4.5000 to \$4.6845 each.
