The Veterans Treatment Court team maintains detailed records of each beneficiary in an Excel spreadsheet, organized by county and plea-in date. The data is consistently tracked and updated on a weekly and monthly basis. At the end of each month, the treatment court staff audit the data for accuracy to ensure quality before submission. All compiled information is then submitted to the Collin County Auditor's Office for reporting.

# Describe the services that your project will provide with this funding, and the specific veteran beneficiaries who will receive the services.

The Coordinator is responsible for developing and maintaining program requirements. The program includes evaluations, counseling, consulting, and clinical therapy sessions led by experienced therapists to address underlying issues and help participants develop coping strategies. It also provides abstinence monitoring and support for unexpected needs, such as utilities, housing, and transportation. Case management is available to address the evolving needs of each participant.

# Describe any other restrictions on eligibility, if applicable (example: income level, VA disability rating, etc.).

Candidates whose criminal cases have been filed in Collin, Fannin, Grayson, Kaufman, Rockwall, Counties. Veterans cannot be charged with crimes in TX Code Criminal Procedure 42.12 (3) (g). Veterans should have a mental health diagnosis. If no diagnosis, will be evaluated.

# **Need Identified:**

# What is the community need(s) or existing service gap(s) that the Proposed Project will address?

The North Texas Veterans Court addresses Veteran needs by offering judicially supervised, multi-agency, team-based approach to Veterans in service areas where resources are not readily available. We are the only Court in the Nation that travels to the Veteran to offer services as well as educating community stakeholders on Veteran needs. Our Court strives to provide the highest level of care to justice involved Veterans in rural communities with resources provided by the Texas Veterans Commission. The North Texas Veterans Treatment Court not only promotes recovery, reduce recidivism and help veterans reintegrate successfully into their communities but also strengthens the veterans ability to thrive at home and in their communities.

# How were community need(s) or gap(s) in service identified? Describe the methods used to identify the need in <u>the service</u> area.

One example we currently utilize is the use of automated weekly mental health assessments, which provides our clinical staff and case managers the ability to identify Veterans who are struggling with life stressors, sobriety or mental health challenges. With the use of the data, our team is able to reach out to the Veteran directly to see if there is a need for additional community resources or adjustments to their treatment plan. This innovative approach provides allows our team to stay ahead of Veteran needs.

Gaps in services were identified by Judge John R. Roach, Jr. as he identified the need to create our Regional Court. The North Texas Veterans Court maintains great working relationships with community stakeholders in four other counties providing resources where local jurisdictions do not have the capacity to sustain Veteran Treatment Courts. By extending support to other counties, it also extends our support to all neighboring counties, effectively expanding our service area and reach more Veterans in need.

### How does the Proposed Project address the identified need(s) or gap(s) in the service area?

The North Texas Regional Veterans Court taps into the unique aspects of military and veteran culture and uses it to the benefit of the veteran. Through the program, former military personnel participate with their fellow veterans, re-instilling a sense of camaraderie that they felt while in the military and providing them with the treatment and tools for coping with their underlying problems. Similar to other treatment courts, the North Texas Regional Veterans Court utilizes a judicially-supervised, multi-agency team-based approach to serve veterans struggling with addiction, mental illness, and other underlying risk factors that contributed to their crime(s). The voluntary program requires participants to undergo intensive treatment and counseling, submit to frequent supervision and random alcohol and/or drug testing, make frequent appearances in court, and to be closely monitored for program compliance. Promotion of sobriety, recovery, and stability through individualized substance abuse and mental health treatment and counseling, coupled with connections for housing, medical, vocational, and other support issues, diverts military offenders away from the traditional criminal justice system and attempts to reduce recidivism through provision of services while holding offenders accountable for their actions and addressing the underlying issues related to their criminal behavior.

# How is the Proposed Project unique from other similar services that may be available in the proposed service area? <u>Be specific</u> with details about what sets your Proposed Project apart.

The North Texas Veterans Court is the only regional court in the country, serving the most veterans in Texas, serving five counties and covering nearly 4,285 square miles, our team is unique in the nation. Our program is dedicated to supporting veterans in Rockwall, Kaufman, Collin, Fannin, and Grayson counties through a comprehensive treatment and rehabilitation process and through the agreement of all five counties Commissioners Courts, District Attorneys Offices, Community Supervision Correction Departments, all sitting Judges and in conjunction with the 1<sup>st</sup> Administrative Judicial Region Judge. Our program's success is rooted in our ability to deliver integrated, innovative, and efficient services that make a real difference in the lives of North Texas veterans. By combining expertise, collaboration, and groundbreaking methods, we are dedicated to helping our veterans successfully reintegrate into civilian life. By not requiring four other counties to provide full staffs, we maximize our resources and ensure that funding is used efficiently and effectively. We travel to the veteran, breaking barriers and providing services to rural communities comparable to those available in larger cities which makes us unique amongst all other Veteran Treatment Courts in the Nation.
