Yoon Kim, County Administrator, presented amendments and revisions to the current Commissioners Court Rules of Procedure, Conduct and Decorum rules. The Commissioners Court added Texas

Government Code sec. 551.007c citing the Open Meetings Act, which allows the Commissioners Court to adopt reasonable rules regarding the public's right to address the Court, including time limits. The second

addition is a citation for Texas Government Code 551.007e citing the Open Meetings Act, in which the

Court will not limit the publics related or unrelated criticism towards the Commissioners Court and

Commissioners Courts business during their allotted speaking time. The last addition is based on the Local

Government Code, sec. 81.023, which allows the Court to find an individual in contempt of court and

issue a fine of \$25 or incarcerate the individual for 24 hours.

Commissioner Fletcher said she believes the Commissioners Court has been too lenient in the past and

some individuals have abused the Courts leniency and have intentionally acted without proper decorum

and respect for the Court. She said the Courts rules are appropriate, fair, and apply to everyone in the Courtroom. Anyone has the right to speak during the public comment time and express their disapproval

with the Courts actions. However, demeaning, insulting, indecent, abusive, profane, vulgar, or threatening

behavior should never be tolerated. Commissioner Fletcher asked the Court to further clarify the amended

copy of the Commissioners Court Rules of Procedure, Conduct & Decorum rules. The advised rules will

now make it clear that the Commissioners Court may punish a person by fine or confinement in jail.

Josh Murray, Lavon, said he has never experienced a level of decorum that was egregious during his years

of attending Commissioners Court. He asked the Court to consider the rules that limit individual's ability to come to Court, such as the dress code. Mr. Murray suggested the Court adopts three separate budgets

including the No New Revenue Rate budget, the Voter Approval Rate budget, and the Property Tax Rate

budget. (Time: 1:54 p.m.)

Commissioner Fletcher suggested anyone who plans to come to Court should plan to dress accordingly. She also mentioned that many speakers who have attended Court have name called/ raised their voices at the Commissioners. Judge Hill agreed with Commissioner Fletchers comments.

Commissioner Hale said he had a discussion with Linda Riggs, County Auditor, about adopting multiple budgets. Ms. Riggs said during last week's Commissioners Court meeting, a comment was made to adopt a budget for grants, however, that is illegal. (Time: 1:58 p.m.)

Jeanne Kelly, McKinney, asked the Court if a contractor has been selected for the CCAS (Collin County Animal Shelter) expansion and expressed her concerns towards some of the surrounding cities not supporting the expansion. She also asked the Court if there were any plans to relieve the crowding at the CCAS. (Time: 1:59 p.m.)

Barbara Lyke, Wylie, said during the October 7, 2024 Commissioners Court Meeting Sheriff Jim Skinner requested money from the Court to pay for a Law Enforcement officer that specialized in drug trafficking, and was denied. Ms. Lyke disagreed with the Courts decision and spoke in support of the SO request. (Time: 2:03 p.m.)

With no further business of the Court, Judge Hill adjourned the meeting at 2:03 p.m.
