YOU ARE DIRECTED TO MAKE THE FOLLOWING MODIFICATION TO THIS CONTRACT

Item #1: Renew contract for a twelve (12) month period at the same terms and conditions of the contract from October 1, 2024, through September 30, 2025.

Item #2: Update Section 5.01 Compensation clause of the agreement to the following-

Payment for contract year October 1, 2024, through September 30, 2025, is \$311,146.00. Payments will be made in four quarterly installments of \$77,786.50. In addition to the fee schedule, each radio registered on the system will be assessed an annual connection fee by Plano, Allen, Wylie, Murphy (PAWM) operators for access to their system. In FY2025, the fee will be \$108 per radio and may be updated annually by PAWM.

From:

Payment for contract year October 1, 2023, through September 30, 2024, is \$210,995.00. Payments will be made in four quarterly installments of \$52,748.75. In addition to the fee schedule, each radio registered on the system will be assessed an annual connection fee by Plano, Allen, Wylie, Murphy (PAWM) operators for access to their system.

Except as provided herein, all terms and conditions of the contract remain in full force and effect and may only be modified in writing signed by both parties.
