Debbie Lindstrom, McKinney, emphasized the importance of the canvass process as a critical step for election integrity. She raised concern about the lack of confirmation that the state-mandated post-election audit aligns with the reported results. Ms. Lindstrom urged the Court to approach the canvass responsibility with seriousness and advocated for careful review and correction of any discrepancies. (Time: 1:36 p.m.)

Judge Hill asked Bruce Sherbet, Elections Administrator, if the partial manual recount was complete. Mr. Sherbet said it had not yet been completed; the deadline for the recount is November 26, following the elections canvass deadline of November 19. Judge Hill asked what remedies are available if the partial manual recount does not confirm the election results and the election has already been certified and canvassed. Mr. Sherbet said it could result in recounts or lawsuits depending on the scenario. Judge Hill confirmed that historically, the partial manual recounts have always confirmed the election results. Judge Hill asked what the repercussions would be if the election was not canvassed by the deadline. Mr. Sherbet said it has to be done; the state does not allow the opportunity to canvass late. (Time: 1:45 p.m.)

Cynthia Brugge, McKinney, expressed her concern on the court's decision for Collin County to adopt hand marked paper ballots. She said she believes the Court needs to work on the idea of changing our election systems in coordination with the selection of a new Elections Administrator and work alongside individuals from CDF (Citizens Defending Freedom). (Time: 1:48 p.m.)

There being no further business, Judge Hill adjourned the meeting at 2:55 p.m.
