

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF FRISCO, TEXAS, RENAMING A PORTION OF ROCKHILL PARKWAY TO PGA PARKWAY; AUTHORIZING THE ERECTION OF STREET SIGNS REFLECTING THE NEW STREET NAME; PROVIDING REPEALING, SAVINGS AND SEVERABILITY CLAUSES AND AN EFFECTIVE DATE.

WHEREAS, the City of Frisco, Texas ("Frisco") has initiated a request to rename a portion of Rockhill Parkway in Frisco, Collin County and Denton County, Texas; and

WHEREAS, the Frisco City Council ("City Council") has investigated and determined that it would be advantageous and beneficial to Frisco and its citizens to rename a portion of Rockhill Parkway to PGA Parkway, as set forth below.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF FRISCO, TEXAS:

SECTION 1: Findings Incorporated. The findings set forth above are incorporated into the body of this ordinance as if fully set forth herein.

SECTION 2: Renaming Rockhill Parkway to PGA Parkway. That portion of Rockhill Parkway identified in yellow in Exhibit A, attached hereto, is hereby renamed to PGA Parkway. All ordinances, plats and official maps of Frisco referring to that portion of Rockhill Parkway are hereby amended, without any additional action, for the sole purpose of establishing and incorporating the renaming of such portion of Rockhill Parkway to PGA Parkway as provided herein. All other provisions of said ordinances, plats and official maps shall otherwise remain in full force and effect.

SECTION 3: Erection of Signs. The City Manager or his designee is hereby authorized to direct the erection of street signs to reflect the renaming of a portion of Rockhill Parkway to PGA Parkway, as provided herein.

SECTION 4: Severability. Should any section, subsection, sentence, clause or phrase of this Ordinance be declared unconstitutional and/or invalid by a court of competent jurisdiction, it is expressly provided that any and all remaining portions of this Ordinance shall remain in full force and effect. The City Council hereby declares that it would have passed this Ordinance, and each section, subsection, clause or phrase thereof irrespective of the fact that any one or more sections, subsections, sentences, clauses and phrases be declared unconstitutional and/or invalid.

SECTION 5: Repealing/Savings. All provisions of any ordinance in conflict with this Ordinance are hereby repealed to the extent they are in conflict; but such repeal shall not abate any pending prosecution for violation of the repealed ordinance, nor shall the repeal prevent a prosecution from being commenced for any violation if occurring prior to the repeal of the ordinance. Any remaining portions of said ordinances shall remain in full force and effect.

SECTION 6: Effective Date. This Ordinance shall become effective from and after its adoption.
