Human Resources (HR) Comments New Personnel/Addition to Headcount

DSHS FY2025 Federal Grant Application for TB Prevention and Control for the one-year grant period 09/01/2024 – 08/31/2025 in the amount of \$82,321.00 with a required county match of \$16,914.00 for a total budget for personnel at \$99,235.00. Grant application is for two (2) existing positions (00300161 and 00300176 - no increase to headcount) partially funded at 39%. County match is from one(1) existing county position (201476) partially funded at 16%. The total amount budgeted is sufficient to cover the estimated cost of salary and fringe based on a calculation of one (1) month at no increase and eleven (11) months at an 8% increase.
