Lynda Scheifele, Princeton, explained that she purchased a historic 1930 Craftsman bungalow at 408 Heard Street in August. Since the initial inspection, the rotted wood has been replaced, primed, and is now awaiting approval from the board regarding the paint color. Ms. Scheifele offered to show pictures of the repairs. Judge Hill noted that just knowing the photos exist is sufficient for now. Ms. Scheifele confirmed

that upon painting the repairs will be fully complete. (Time 1:34 p.m.)

Jacque Weinberg, McKinney, spoke on the repairs done to her historic home at 1207 West Louisiana after receiving a letter denying her tax abatement due to these needed repairs. Judy Moody, Myers Park, spoke to the approval of repairs to properties located at 408 Heard Street and 1207 West Louisiana for tax purposes. Ms. Moody agreed to approve them as long as there was proof that the required repairs were in progress. There are eight other properties that are still under review.

The Court expressed concern about verifying the work done on the properties before approving them due to the close approval deadline. Ms. Moody indicated the commission is a month behind due to a lack of forum in December. She explained that typically the commission would visit the properties for verification but acknowledges that time is limited. Judge Hill inquired with Ms. Moody as to the possibility of meeting with Ms. Scheifele and Ms. Weinberg, who offered to provide photos of said repairs, while court is in recess for executive session to further discuss the situation. After meeting with Ms. Scheifele and Ms. Weinberg, Ms. Moody informed the court the repairs are sufficient and recommends approval. (Time 2:48 p.m.)

2. General Discussion Items:

Presentation, discussion and any action regarding:

a. <u>AI-57503</u> Budget amendment in the amount of \$112,323 for Animal Shelter, Animal Control and Sheriff's Office Jail overtime, Budget.

Yoon Kim, County Administrator, discussed budget amendments for department overtime totaling \$112,000, specifically for the Animal Shelter, Animal Control, and the Sheriff's Office. The first being the Animal Shelter with \$46,100 for overtime and \$34,400 for Animal Control overtime. These funds will come from the Animal Shelter's fund balance, which is approximately \$2 million. The amounts are based on FY 2024 actual expenditures and should cover overtime for the rest of the fiscal year. In respect to the Sheriff's Office, current jail operations overtime budget is currently at \$86,601.02. A request was made for \$31,823 from Sheriff's Office salary savings to increase it to a total of \$118,424.02. In addition, Mr. Kim requested authorization to move salary savings from unfilled positions in the Sheriff's Office to the jail operations overtime fund. Mr. Kim stated the Sheriff's Office has reduced overtime costs over recent pay periods, and this policy would provide flexibility to manage overtime within budget constraints. The overall aim is to ensure overtime expenses are covered and compliant with the policy passed in August 2024, requiring overtime to be funded from each department's budget. (Time 1:44 p.m.)

b. AI-57386 89th Legislative Session Update, Administrative Services.

Russell Schaffner, Deputy County Administrator, provided an update on two legislative bills. SB779, by Senator Middleton, focuses on changing the definition of "public nuisance" to limit its use in large-scale litigation like the opioid litigation, potentially affecting lawsuits in counties like Collin County. SB982, by Senator Hughes, allows property owners to appeal appraisal review board decisions to a justice court if property value in question is under \$20,000. This could increase justice courts volume. (Time 1:47 p.m.)

Commissioner Fletcher stated she attended the same conference as Mr. Schaffner and did not have any further updates. (Time 1:50 p.m.)

d. AI-57497 Regional Transportation Council monthly update, Commissioner, Precinct 4.

Commissioner Webb stated the discussion at the last meeting centered around the DART (Dallas Area Rapid Transit) tax rate and whether to remain neutral on the issue. This came after an end of February deadline was suggested to remove the proposal from legislation and allow the tax rate to stay the same. Commissioner Webb put forward a proposal to remain neutral on the legislative agenda concerning the tax rate, with a vote of 16 to 17 in favor of staying neutral after a lengthy debate. All other agenda items were pushed forward. (Time 1:51 p.m.)

Judge Hill recessed Commissioners' Court into Executive Session at 1:52 p.m. in accordance with Chapter 551 of the Government Code, to discuss the following subjects:

<u>AI-57496</u> Legal advice and consultation on possible legal liabilities and outcomes of recognizing or not recognizing the purported release of extraterritorial jurisdiction by the Town of St. Paul, including litigation, Engineering.

Public Comments not related to an item on the Agenda.

Kevin Rohr, Farmersville, discussed the lack of fire protection for residents living in unincorporated areas. Mr. Rohr stated he has done extensive research and found that the county is not legally obligated to provide fire services. He pointed out that most people are unaware they do not have fire coverage and emphasized that the county, which has seen an increase in property taxes due to rising home values, could help fund fire departments. Over the last 10 years, the City of Farmersville has requested additional funding, specifically asking for \$300,000 to \$400,000. His suggestion was for the county to provide financial support to fire departments while cities could use the funds to reduce local taxes, preventing "double dipping." Mr. Rohr critiqued the Emergency Services District (ESD) as a solution, stating it removes the county's responsibility and puts the burden on local residents. (Time 2:51 p.m.)

Dan Schmoll, Princeton, discussed fire services in his area, particularly the loss of a volunteer fire service that was replaced with a new service. Mr. Schmoll suggested exploring funding alternatives, such as tapping into the state's \$20 billion fund. He also requested preventative measures such as fire extinguisher refilling programs. (Time 2:53 p.m.)

Judge Hill stated these topics would be on next week's agenda.

There being no further business of the Court, Judge Hill adjourned the meeting at 2:54 p.m.
