It is assumed that there is no cost impact with this direction as we are changing from one standard size louver to another. If Christman believes there is, please inform design team and ownership prior to ordering anything or proceeding with any work.

Response from Cooper Martindale Summit Consultants, Inc. on Wednesday, Dec 11, 2024 at 03:48 PM CST

Per conversation with Architect this afternoon, louvers to be sized at 108"x36" (WxH) each in order to align across the distance of 2 openings on the facade of the parking garage (refer to attached picture for reference). Louvers to be mounted below these openings. Route and transition exhaust ductwork as required.

The suggested louver size of 94"x40" is not available in standard louver sizes. Louvers L-3A, L-3B, L-4A, and L-4B may be either of the sizes listed below (WxH):

96"x42" (Preferred) 102"x36"

There is not a louver specification section. Provide basis of design or an equal (as stated in the Louver Schedule) that meets the requirements listed in aforementioned schedule:

- Provide extruded aluminum, 6" drainable stationary wall louver with insect screen.
- Provide louver with anodized finish, coordinate color with Architect.
- For installation: provide transition or adaptor where required to adapt ductwork to neck size.
