Please find the pricing attached for SEDALCO Change Proposal #CO-061. This cost is associated with the construction of a temporary wall within the existing Jail per the request of the County and confirmed in RFI #047. SEDALCO performed a walk with the Owner recently to confirm the requirements and location of this wall.

SEDALCO has included cost in this proposal to remove the wall at a later date established by the County so long as it fits within the timeline of the project. Per direction of David Dooley via email on 03/12/25, SEDALCO has removed the money to patch/paint the CMU and concrete column where the wall will be built. Per the walk with David Dooley, the County will repair and replace the VCT flooring that will be damaged when the wall is anchored to the existing slab.

The cost of this change is \$14,994.12. Upon acceptance of this proposal, please issue a Change Order to the Contract to reflect the added cost.
