2. General Discussion Items:

Judge Jay Bender presented projections for the future judicial needs of Collin County Courts at Law. He explained that based on data from the OCA (Office of Court Administration) the current judicial workload in Collin County indicates that each County Court Judge is handling 22% more cases than the recommended capacity. Judge Bender outlined an immediate need for two additional courts with a total of eleven courts by 2030. Judge Bender stated the projected population growth in the County could reach 2.6 million by 2060. Comparisons with other counties such as Dallas, Tarrant, and Denton further support the need for additional resources. He explained that space constraints in the current courthouse prevent the addition of any new courts. Judge Bender stressed that County Courts do not currently have space for growth due to the reallocation of two courtrooms originally planned for County Court expansion to District Courts. Commissioner Hale asked Judge Bender how additional courts in the current space could be handled. Judge Bender stated that it would not be possible due to the lack of extra courtrooms available, the ability to rotate judges, or share courtrooms without creating inefficiencies. Judge Bender asked Commissioners to consider long-term planning as well as urgent action to support judicial infrastructure before it becomes a crisis. (Time: 2:03 p.m.)

d. AI-57386 89th Legislative Session Update, Administrative Services.

Russell Schaffner, Deputy County Administrator, provided a update on the 89th Legislative Session. He highlighted Senate Bill 293 which includes a judicial pay raise and is still under consideration with the deadline approaching. He explained that House Bill 40 which mandates that counties allocate courtroom and chambers space for business courts when expanding courthouses is now headed to the governor. Mr. Schaffner said House Bill 3348 increases administrative fee revenue from \$150,000 to \$300,000 and will take effect immediately upon the governor's signature. He stated House Bill 1998 raises the purchasing threshold from \$50,000 to \$100,000 and streamlines procurement by reducing the need for formal bids. Mr. Schaffner explained House Bill 3234 allows for counties with populations over one million to bypass permit requirements for construction projects in other jurisdictions while still following local rules. Last, Mr. Schaffner stated Senate Bill 2753 introduces a significant change to election procedures by extending early voting through the Monday before Election Day. He said this will allow for a flexible implementation timeline determined by the Secretary of State and will potentially take effect as late as August 1, 2027.

Commissioner Webb expressed satisfaction with the progress on House Bill 3348 noting that its passage and hopeful signing by the Governor will assist the County in covering additional administrative costs. (Time: 2:09 p.m.)

3. Executive Session Items:

Public Comments not related to an item on the Agenda.

Shannon White, Founder, Grace to Change, requested consideration for a portion of the \$377,000 opioid funding to support their services. She stated Grace to Change nonprofit is the only in-person adolescent treatment provider in Collin County working with CPS (Child Protective Services) and foster care affiliates. She emphasized the program's financial challenges which rely heavily on fundraising and asked the Court to consider supporting their mission. (Time: 2:11 p.m.)

Lee Moore, McKinney, asked Commissioners to delay approval of the upcoming ES&S (Elections Systems and Software) maintenance contract until after the Texas Legislature finalizes key Election Bills particularly Senate Bill 2753 addressing the three-day gap between early voting and Election Day. She referenced President Trump's executive orders advocating for hand-marked paper ballots and emphasized the risk of spending taxpayer money on potentially obsolete services. Ms. Moore requested Commissioners to include refund clauses or delay the contract to ensure alignment with forthcoming State and Federal election requirements. (Time: 2:14 p.m.)

Debbie Lindstrom, McKinney, expressed support for Presidential Executive Order 14248 which requires that by September 21, 2025 all voting machines must not use barcodes or QR (Quick Response) codes and must comply with EAC VVSG 2.0 (Election Assistance Commission Voluntary Voting System Guidelines) standards. Ms. Lindstrom stated ES&S (Election Systems and Software) machines are not currently certified under those standards nor are they in the testing queue. She asked Commissioners to include an escape clause in the ES&S contract to protect taxpayer funds if compliance is not met. (Time: 2:17 p.m.)

Chuck Reynolds, Celina, expressed support for Presidential Executive Order 14248 emphasizing its call to eliminate ballot barcode translations and promote hand-marked ballots. He said electronic touchscreen voting introduces multiple translations and undermines voter trust. Additionally, Mr. Reynolds cited recent security concerns identified by Dr. Walter Daugherity, Texas A&M Professor as evidence of growing electronic vulnerabilities that could threaten election integrity. Mr. Reynolds requested Commissioners consider reinstating hand marked ballots for the 2026 midterm and all future elections. (Time: 2:19 p.m.)

There being no further business of the Court, Commissioner Williams adjourned the meeting at 2:19 p.m.
