Judge Hill explained that the wage discussion would occur during the upcoming August Budget Workshop and thanked her for her service and effective presentation. David Shackelford, McKinney, stated his experience in working at a homeless shelter in Dallas and spoke in support of establishing a county-supported homeless shelter. He proposed that the County either build or provide land for such a facility noting charities could cover additional costs if land was secured. Mr. Shackelford stated the shelter would deter crime, reduce violence, support people exiting jail, and help prevent other counties from offloading high-risk individuals into the area.
