## Public Comments not related to an item on the Agenda.

Barbara Lyke, Wylie, addressed concerns about robocalls and phone scams specifically referencing the Stopping Bad Robocalls Act and the TRACED Act. Ms. Lyke highlighted that while the bill aimed to curb robocalls it ultimately excluded public and private schools from protection. Ms. Lyke stated she shared correspondence with

Wylie ISD officials about her concerns who acknowledged the difficulty in preventing such activity. She also stated she filed a police report in 2021 with the Collin County Sheriff's Department for spoofing incidents. Ms. Lyke emphasized the need for future legislation to explicitly include schools in these protections. She asked Commissioners for advisement as to who to contact in order to advocate for such changes. Judge Hill informed Ms. Lyke to contact State Representative Candy Noble for State or U.S. Representative Keith Self for Federal concerns. Commissioner Hale explained that State Law had been passed in 2019 addressing spoofing categorizing it as a violation under the Texas Penal Code if there was intent to defraud, harass, or cause harm. Ms. Lyke was advised that such incidents should be reported to local law enforcement such as the Collin County Sheriff's Office with follow up being necessary for further investigation. Ms. Lyke confirmed that she had previously filed a case report regarding spoof calls.

There being no further business of the Court, Judge Hill adjourned the meeting at 1:39 p.m.
