Provide Labor, Equipment, and Materials to perform the install of Chilled Water Booster Pump system into the Collin County Jail. The proposal is based off the below scope:

Per MD Engineering Mechanical Plans Dated 3/22/24

- Perform (4) pipe freezes on 4" CHWS & CHWR pipes
- Furnish & install (2) 4" isolation valves as per drawings.
- Furnish and install (1) 4" 3-way control valve
- Pour 5'x5' concrete pad for new booster pumps
- Set new (2) Armstrong Pumps & (2) ABB VFD's
 - (2) Armstrong Horizontal Base Mounted Split Coupled End Suction Pump
 - (2) ABB Model ACH580 Variable Frequency Drive
 - (2) BELIMO 3 Way Control Valve
- Connect piping to pumps
- Run power from electrical room for both pumps. It is planned for conduit to be trenched in the dirt in lieu of hanging from ceiling
- BAS controls is not included
- Remove/dispose of all work-related debris and trash
