We appreciate the opportunity to continue supporting the Collin County Healthcare project. We value our ongoing collaboration with you and your team.

As part of our original scope, PGAL, Inc. was contracted to provide architectural and engineering design services for the core and shell design of the facility located at 2330 Bloomdale Road. As per your request to add design scope for the structural assessment and interior finish-out of the 3rd floor, we understand you are ready to move forward with partial interior improvements necessary to finish-out the space for occupancy and use.

Accordingly, we propose to provide additional architectural and engineering services to design, coordinate, and submit construction documents for permit approval and construction of the interior finish-out. These services will include:

- Submittal to authorities having jurisdiction and respond to review comments
- Construction administration tasks including submittal reviews and responses to RFIs and construction progress observations

PROJECT UNDERSTANDING

The County has requested PGAL to amend the base scope of work to include finish-out of part of the 3rd floor shell space:

- Finish-out the north side of the 3rd floor to be finished out for a temporary Storage Room. After completion, the County may convert the space to Offices. (Approximately 8,600 +/- SF)
- Design public restrooms identical to the 2nd floor
- Design the Wellness room and Break room, identical to the 2nd floor
