**Order Calling an Election to Confirm the Creation of the Collin County Emergency Services District No. 1, and authorize the imposition of a tax not to exceed the rate allowed by section 48-E, Article III, Texas Constitution.**

Whereas, the Collin County Commissioners Court received a petition from petitioners seeking to create the proposed Collin County Emergency Services District No. 1 (“ESD No. 1”); and

Whereas, written requests for inclusion in the district were sent to the municipalities having overlapping limits and extraterritorial jurisdiction with the territory of the proposed ESD No. 1; and

Whereas, Collin County provided notice of public hearing stating that the creation of a district is proposed; that the district is to be created and is to operate under Article III, Section 48-e, of the Texas Constitution, as proposed by S.J.R. No. 27, Acts of the 79<sup>th</sup> Legislature, Regular Session, 1987, and adopted by the voters at an election held November 3, 1987; the name of the proposed district; the district’s boundaries as stated by the petition; the place, date, and time of the hearing; and that each person who has an interest in the creation of the district may attend the hearing in person and present grounds for or against the creation of the district; and

Whereas, a copy of the notice of public hearing was posted at the courthouse not later than 21 days before the hearing, and a copy of the notice was published in a newspaper of general circulation in the County once a week for two consecutive weeks – the first publication occurring prior to 21 days before the public hearing; and

Whereas, a public hearing was conducted on July 28, 2025, at 1:30 p.m., and persons who had an interest in the creation of ESD No. 1 were invited to attend and present grounds for or against the creation of ESD No. 1; and

Whereas, after the public hearing, the Commissioners Court considered the petition and each issue relation to the creation of ESD No. 1; and

Whereas, the Collin County Commissioners Court previously granted the petition by executing the resolution approving the petition for petitioners seeking to create Collin County ESD No. 1.

It is therefore ordered by the Commissioners Court of Collin County, Texas, that

1. The petition is in proper form and conforms to the requirements of Sections 77.012 and 77.015, Texas Health and Safety Code (“Code”).
2. The petitioners have deposited with the County Clerk the amount of money equal to the amount required by section 775.0013(b) of the Code for the costs related to the proposed creation of ESD No. 1.
3. The petition is signed by at least 100 qualified voters who own taxable real property in the territory of the proposed ESD No. 1.

4. Notice of Public Hearing has been posted in conformity with Section 775.015 of the Code.
  5. The creation of ESD No. 1 as presented in the petition is feasible and will promote the public safety, welfare, health, and convenience of persons residing in the proposed district.

  - f. The city of Hebron and its extraterritorial jurisdiction
  - g. The city of Lucas and its extraterritorial jurisdiction
  - h. The city of St. Paul and its extraterritorial jurisdiction
  - i. The city of Trenton and its extraterritorial jurisdiction
  - j. The city of Van Alstyne and its extraterritorial jurisdiction
8. ESD No. 1 will still promote the public safety, welfare, health, and convenience of persons residing in the territory of an amended proposed district, if any of the territory in the municipalities' limits or extraterritorial jurisdiction as included in Section 6, a-r.
  9. An election will be held to confirm the creation of COLLIN COUNTY EMERGENCY SERVICES DISTRICT NO. 1 and authorize the imposition of a tax not to exceed the rate allowed by Section 48-e, Article III, Texas Constitution.
  10. The election shall be on the 4<sup>th</sup> day of November, 2025, which date is the next available uniform election date under Chapter 41, Texas Election Code.
  11. The creation of ESD No. 1 at the election shall be by majority vote of all the voters; except that ESD No. 1 may not include territory in a municipalities limits or extraterritorial jurisdiction unless a majority of the voters residing in that territory who vote at the election vote in favor of creating the district; the election must be canvassed to ascertain, in addition to the voters within the entire proposed ESD No. 1, the votes within the boundaries of each municipality's limits within the proposed ESD No. 1 and within each individual municipality's extraterritorial jurisdiction included within the proposed ESD No. 1.
  12. Exhibit "A" incorporated herein by reference, is the petition, proposed tract description, and original map of the proposed boundaries of ESD No. 1.
  13. Exhibit "B" is the resolutions and correspondence from municipalities consenting to the creation of ESD No. 1.
  14. Exhibit "C" is a map of the boundaries of ESD No. 1, approved by the Commissioners Court, as defined area for the proposed ESD No. 1, including territory for which the municipalities consenting regarding the boundaries of ESD No. 1.
  15. At the election, the following proposition shall be submitted to the qualified voters who reside in the proposed ESD No. 1 territory:
