Commissioner Hale asked for clarification regarding the receipt of only two price quotes, noting a large disparity between the proposals. He expressed concern that one vendor submitted a three-year contract totaling \$105,000, while another offered a one-year contract valued at \$505,000. Commissioner Hale emphasized the necessity of understanding the reasons behind this significant price difference and stressed the importance of addressing these issues prior to moving forward.

Michelle Charnoski, Purchasing Agent, explained that upon receipt of quotes, the Purchasing Department conducts a thorough review to ensure compliance with the County's specified requirements. This process involves consultation with the relevant department and, when necessary, engagement with architects or engineers to obtain additional input. Further, the department reviews the financial responsibility and references of all parties involved to ensure alignment before proceeding. Ms. Charnoski confirmed that this particular case followed the established procedure and offered to conduct a further review.

Commissioner Hale noted inconsistencies in the contract terms and requested that the item be held for one week to allow additional time for inquiry. He recommended that further information from the Facilities Department could provide greater clarity on the matter. (Time: 1:34 p.m.)

Commissioner Webb reported that the recent monthly meeting largely focused on Transit 2.0, particularly the implications of DART membership versus non-membership and broader participation in regional transit planning. He noted that a proposal to terminate current consultants and engage in further consulting work was rejected. Instead, the Council opted to establish a subcommittee tasked with advancing the more practical recommendations from the Transit 2.0 study. The subcommittee will include representatives from the three transit agencies, as well as member and non-member jurisdictions, to develop policies aimed at encouraging broader participation in transit initiatives. This effort is driven by concerns over the Metroplex's projected population growth from 8 million to 16 million, which makes reliance on roadway expansion alone unsustainable.

Commissioner Webb also announced approval of the 2026–2027 Unified Planning Work Program, based on the UTP (Unified Transportation Program), and a Council-endorsed call for electric vehicle charging station projects. Fifteen primary sites were identified, all required to be located on public property and accessible 24 hours per day 7 days per week.

In further discussion, Judge Hill and Commissioner Webb explored ways to incentivize non-member cities to engage in regional transit without mandating full DART membership. Commissioner Webb clarified that the objective is not necessarily to increase DART membership but to enable cities to access services through alternative means, such as contracting for specific services. He cited McKinney as an example, now able to purchase rail services without formally joining DART. Judge Hill expressed concerns about fairness to dues-paying member cities. Commissioner Webb acknowledged the concern and noted that discounted rates are unlikely. He added that a potential reduction in the current one-cent sales tax could make DART membership more financially viable for additional cities.

Commissioner Webb emphasized the Council's goal of making transit options more accessible to rapidly growing suburban areas. He pointed to the emergence of micro-transit that offer flexible, on-demand services, as the likely direction for future regional transit. He also suggested allocating a portion of regional transit funds to help non-member cities invest in infrastructure or services. Commissioner Webb concluded by clarifying that future transit projects will not necessarily involve rail, with exceptions limited to specific cases such as McKinney or Arlington. (Time: 5:24 p.m.)
