Collin County has awarded your company as the supplier for the above referenced contract per Court Order No. \_\_\_\_\_\_\_\_. It is understood all terms, conditions and prices will be held firm per the TIPS Cooperative Contract No. 25010401. This contract is for emergency services for roof repairs and maintenance for the County. The contract term begins on the date of award and will continue through and including April 30, 2026, with the option to renew contract for three (3) additional one (1) year periods. The County will also have the right and option to terminate the contract upon thirty (30) days written notice.

This is a notification only, purchase orders will be issued on an as needed basis. The delivery address or project location for orders or services will be printed on each purchase order issued.

A purchase order is required for all products or services ordered. Do not deliver any products or perform any services without first receiving a purchase order.

A Payment and Performance Bonds will be required in accordance with Chapter 2253 of the Texas Government Code. If required, bonds are to be provided no later than ten (10) calendar days of notice from Collin County. Bonds shall be in the amount of one hundred percent (100%) of the total contract price in such form as is satisfactory to and in accordance with Chapter 2253 of the Texas Government Code and all other applicable Texas Law and on the form specified. These bonds shall be executed by a corporate surety company duly authorized and admitted to do business in the State of Texas and licensed to issue such a bond in the State of Texas. The Contractor shall notify its corporate surety of any Contract changes.

Please submit a certificate of insurance with Collin County as the certificate holder within ten (10) business days from notification of award.
