1. Question: Are there any changes in the build from what was posted in OpenGov?

3. Question: Where are installs and maintenance currently done?

Answer: Typically, new vehicles have installs completed at the dealership. For vehicles already on the lot, sometimes Collin County does the installs, and sometimes Collin County sends them out to an outside vendor. It depends on the volume of vehicles needing install work.

Maintenance is done by Collin County.
