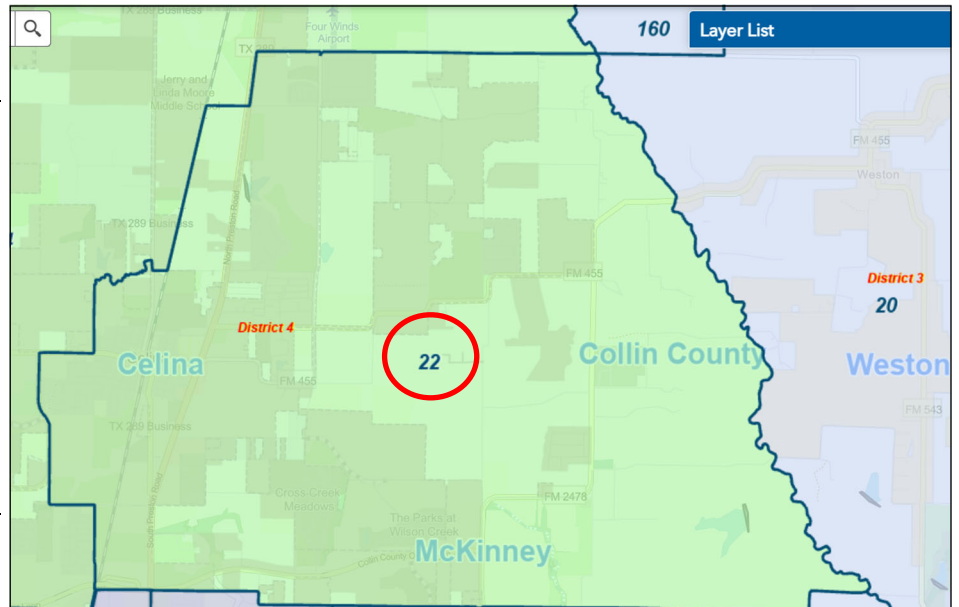

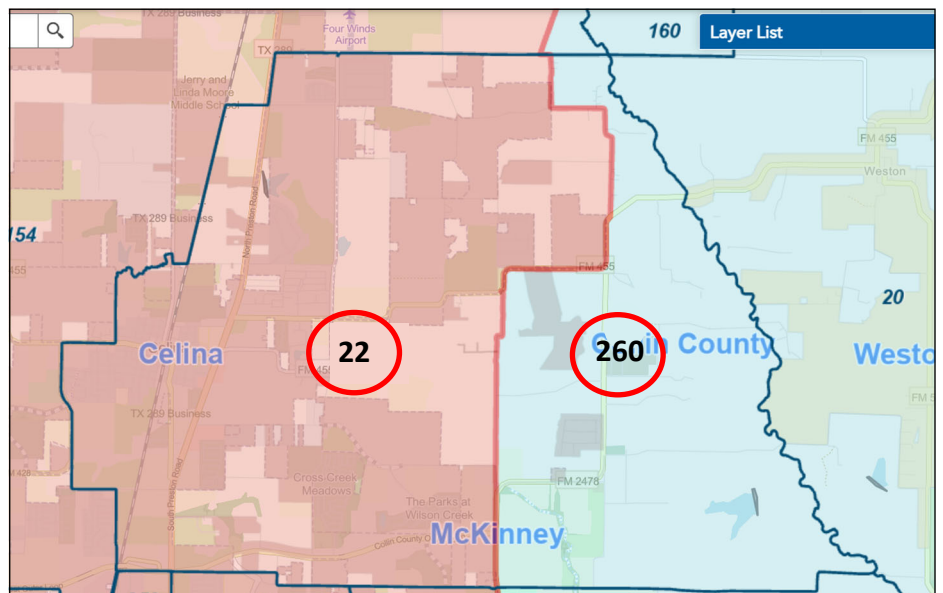

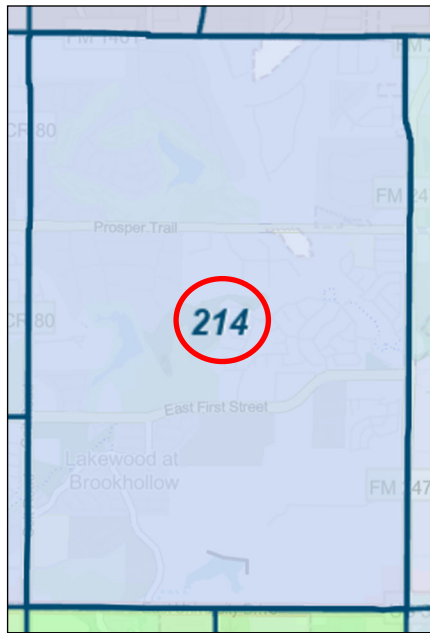

Precinct 22 was initially going to be split because the Active registered voter totals exceeded 5,000.</p> <p><b>NEW SPLIT:</b> South on County Road 133 from precinct line and County Road 134. Continue south all the way to W FM 455. Head south/southwest on FM 455 to County Road 127. Follow County Road 127 south to FM 2478, then south on FM 2478 to precinct line at Choate Pkwy. and County Road 125.</p>

<b>Summary of Changes:</b>	Precinct 85 will be divided along the proposed Congressional line. This will require two splits.
	<b>SPLIT:</b> Proposed Congressional line runs east on Legacy Dr., north along Hoblitzelle Park, then east/southeast on Hoblitzelle Park back to Legacy Dr. The Congressional Line cuts through the Garden Gate Apartments (1201 Legacy Dr.), separating that section from Precinct 77 and merging it into Precinct 85.
	<b>SPLIT:</b> The proposed boundary line continues south along Alma Dr. to Barton Creek Ln, west on Barton Creek Ln to Bellehaven Dr., north on Bellehaven Dr. to Seabrook Dr., and east on Seabrook Dr. back to Alma Dr.
	This Congressional line results in the creation of new Precinct 267. Proposed Precinct 267 will have <100 active voters.

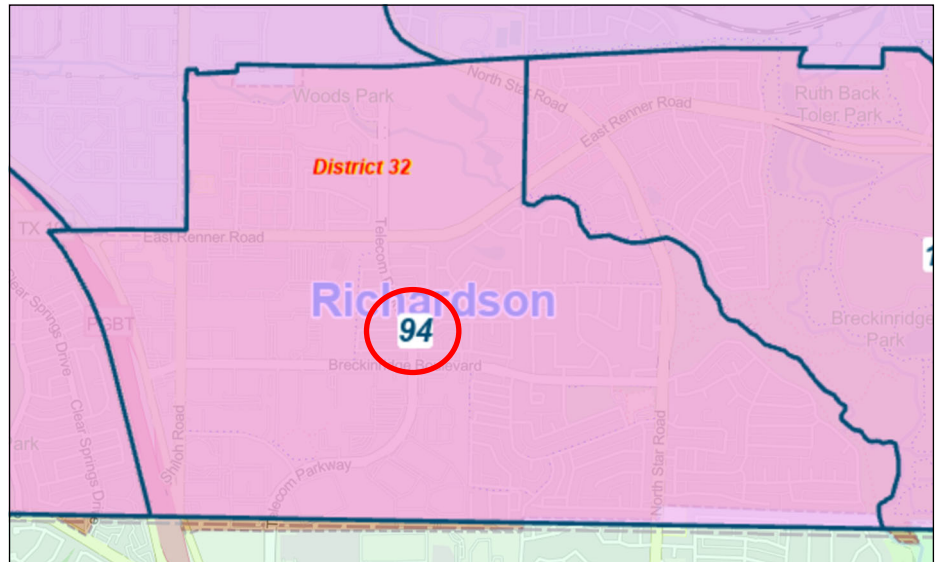

	<b>SPLIT:</b> North to south on the McKinney and Frisco city line from precinct line to precinct line. This will create Precinct 271. Precinct 271 will then split along Congressional line in the southeast corner.
	<b>PRECINCT 271 SPLIT:</b> The proposed Congressional line follows the split along the Collin County and Frisco city line from the southern precinct line north/northeast, then east to precinct line.
	The proposed Precinct 271 split will create Precinct 272. Precinct 272 will have one residence with one active voter.



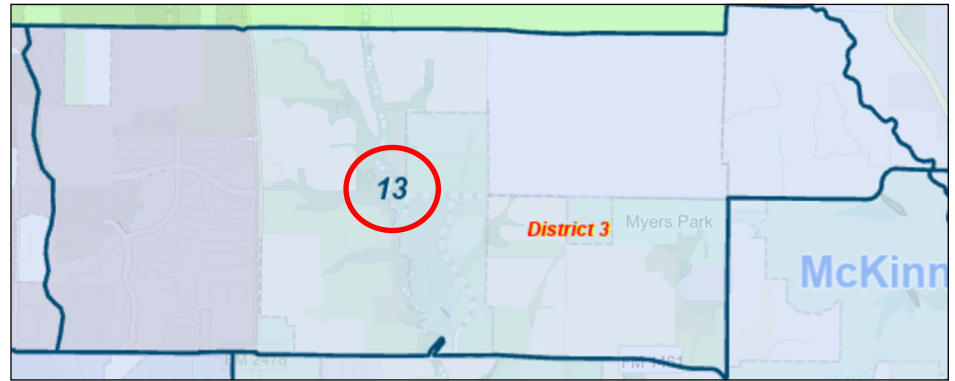

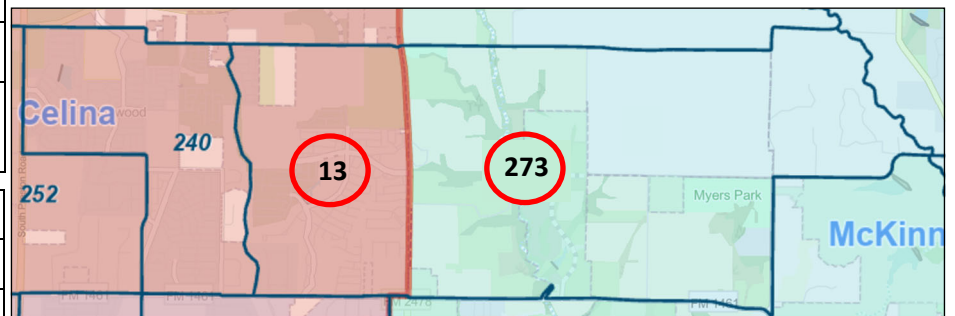
