| <b>SUMMARY</b>             | <p>LifePath Systems will provide specialized mental health coverage 24 hours a day, 7 days a week on-site at the Collin County Detention Facility. One workforce member will be located on site around the clock (see coverage schedule below). Coverage is to be provided by a Qualified Mental Health Professional (QMHP) who is a member of the LifePath Mobile Crisis Outreach Team (MCOT). All QMHPs involved in the contract will have a minimum of a bachelor's degree in psychology or related field and at least 3 years working in community mental health with individuals diagnosed with serious mental illnesses.</p> <p>QMHPs will work on-site in coordination with Detention Facility staff and healthcare contractors. On duty QMHP will have the following responsibilities at book-in:</p> <ol style="list-style-type: none"> <li>1) Identify current or previous LifePath clients,</li> <li>2) Complete a MH evaluation for those who screen positive &amp;/or who are current or previous LifePath clients, and</li> <li>3) Determine level of watch.</li> </ol> <p>QMHP will be responsible for coordinating community-based mental health (MH), intellectual or developmental disabilities (IDD), and substance use disorder (SUD) services upon release of individuals identified with MH, IDD, or SUD needs.</p> |
