County Clerk's Office Scope of Work

- 1. Demo existing windows & Frames
- 2. Demo Wood Swing gate & Frames
- 3. Demo Gypsum Wall board and metal stud partitions, pony wall & Full walls.
- 4. Modify Existing Furr Down to accept new Window walls.
- 5. Install new Gypsum Wall board and stud posts w/ 1/4" Window groove in existing countertop
- 6. Install new Window Walls w/ ½" tempered glass w/o pencil finish with speaking holes and covers.
- 7. Install new Gypsum wall board with 4' x 3'-8" Sliding glass window and new 1' ¾" Plam wood door 3'-0" 7'-0" with keyed lockset.
- 8. Move and reset ceiling tiles and lighting as required.
- 9. Paint all new Gypsum wallboard walls, furr-downs, posts as shown.
- 10. The duration will be approximately 2 weeks.
- 11. Paint all new Gypsum wallboard walls, furr-downs, posts as shown.
- 12. The duration will be approximately 2 weeks.
- 13. The duration will be approximately 1 week.
- 14. The proposal is good for 60 days.
- 15. Remove and reinstall (12) existing number signs as required after furr-downs are adjusted or constructed.
- 16. Supply electrical power for new electrified hardware as required. Connection at nearest junction box as required.
