COMMISSIONERS COURT ACTION REQUESTED

It is requested that the Commissioners Court approve renewal of Bid No. F2024010, Annual Contract for Prisoner Extradition Services, for the second and final optional twelve (12) month period at the same firm fixed prices.

BACKGROUND

On November 7, 2023, the Commissioners Court, through Court Order #142094, awarded Bid No. F2024010, Annual Contract for Prisoner Extradition Services, for the Sheriff's Office, to US Corrections LLC.

The award was based upon low bid meeting specifications and contained options to renew for two (2) additional twelve (12) month periods.

On July 16, 2024, the Commissioners Court, through Court Order #143524, approved the first renewal option.

The purpose of this contract is for extradition transportation by ground or air on an as-needed basis for an estimated two hundred fifty (250) violators who are being extradited back to Tarrant County for incarceration and adjudication. Juvenile Services transports will be on a case-by-case basis.

The vendor notified Purchasing in writing that their prices will remain firm through November 6, 2026. The Sheriff's Office notified Purchasing in writing that they are pleased with the vendor and want to renew.

Therefore, it is the joint recommendation of the Sheriff's Office and Purchasing that the Commissioners Court approve renewal of Bid No. F2024010, Annual Contract for Prisoner Extradition Services, for another twelve (12) month period.

FISCAL IMPACT

Expenses for the last twelve (12) months were \$673,249.00. Funding has been requested in the FY 2026 budget in account 10000-2026 General Fund/2110210000 SO Warrants/569011 Professional Services.
