SUBJECT: **BID NO. F2024010 - ANNUAL CONTRACT FOR PRISONER EXTRADITION SERVICES - SHERIFF'S OFFICE - US CORRECTIONS LLC - PER UNIT PRICE**

**COMMISSIONERS COURT ACTION REQUESTED**

It is requested that the Commissioners Court award Bid No. F2024010, Annual Contract for Prisoner Extradition Services, for the Sheriff's Office, to US Corrections LLC at the per unit price.

**BACKGROUND**

Notice of the County's intent to bid was advertised in local newspapers, as required by State statute, and posted on the Internet, the Arlington Black Chamber of Commerce, the Fort Worth Hispanic Chamber of Commerce, the Fort Worth Metropolitan Black Chamber of Commerce, and the Tarrant County Asian American Chamber of Commerce. One hundred thirty-one (131) vendors were contacted and requested to participate in this bid process. All documents pertaining to this bid were posted on the Tarrant County website and were downloaded by interested bidders. A pre-bid conference held on October 3, 2023 was attended by two (2) vendors as well as representatives from the Sheriff's Office and Purchasing. Two (2) bids and one (1) no-bid were received.

Bids were evaluated by the Sheriff's Office and Purchasing representatives. Award recommendation is to the low bid meeting specifications.

Blue Knight Security LLC was deemed non-responsive because vendor was removed from Tarrant County's approved vendors list for a period of two (2) years, effective October 17, 2023. The bid received from US Corrections LLC meets all specifications and is acceptable to the Sheriff's Office.

The term of the contract is twelve (12) months, effective November 7, 2023, with two (2) options for renewal periods of twelve (12) months each.

This contract is for extradition transportation by ground or air on an as-needed basis for an estimated 1,200 violators who are being extradited back to Tarrant County for incarceration and adjudication. Juvenile Services transports will be on a case-by-case basis.

Therefore, it is the joint recommendation of the Sheriff's Department and Purchasing that Bid No. F2024010, Annual Contract for Prisoner Extradition Services, be awarded to US Corrections LLC at the per unit price.
